On the above date, the Public Disclosure Commission (PDC) will hold an Adjudicative Hearing (Enforcement hearing) concerning allegations that the Grant County Republican Central Committee violated: (1) RCW 42.17A.220 by failing to timely deposit monetary contributions within five business days of receipt; and (2) RCW 42.17A.235 by failing to file or timely file Monetary Contribution reports (C-3 reports) and Campaign Summary Receipts and Expenditure reports (C-4 reports) disclosing contribution and expenditure activities for calendar years 2015 through 2018.

PDC staff is in the process of finalizing the Report of Investigation with Exhibits, and a Notice of Administrative Charges for an Enforcement hearing, and once those documents have been signed, I will email you PDF copies of both documents.

The Commission is scheduled to hold a hearing on the allegations to determine if actual violations occurred, and if appropriate, to assess penalties. The hearing will be conducted in accordance with the Administrative Procedures Act (APA - RCW 34) and WAC 390-37-100.

At the Enforcement hearing, the Commission may also accept a signed Stipulation to Facts, Violations, and/or Penalties (informal settlement) if one is offered and agreed to by both parties in accordance with WAC 390-37-090. If the Officers of the Grant County Republican Central Committee you would like to discuss the possibility of entering into a Stipulated Agreement, please let me know at your earliest convenience and I can assist you with that.

The Commission has the authority to assess a penalty of up to \$10,000 per violation, or they can find apparent violations and refer the matter to the Attorney General for additional authority or higher penalties.

Notice of Administrative Charges

Jurisdiction

The Public Disclosure Commission (PDC) has jurisdiction over this proceeding pursuant to Chapter 42.17A RCW, the state campaign finance and disclosure laws; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC. These charges incorporate the Report of Investigation and all related exhibits by reference.

Allegations

PDC staff is alleging the Grant County Republican Party Central Committee, a Bona Fide Political Party Committee, violated RCW 42.17A.235 and .240 by failing to file or to timely file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contributions and Expenditures reports (C-4 reports) disclosing contribution and expenditure activities undertaken for calendar years 2015 through 2018.

Facts

1. The Grant County Republican Party Central Committee (Committee) is a Bona Fide County Political Party Committee located in Moses Lake, Grant County, and has been registered and reporting with the PDC dating back to the 1990's.
2. On February 2, 2017, the Committee filed a Committee Registration (C-lpc report) as a Continuing Bona Fide Political Party Committee, selecting the Full Reporting Option and listing Danny Stone as Chairman and Campaign Manager and Rae A. Journey as Committee Treasurer. The C-1pc was in effect for the remainder of 2017 and all of calendar year 2018.
3. On February 11, 2014, the Committee filed a C-lpc report as a Continuing Bona Fide Political Party Committee, selecting the Full Reporting Option and listing Kimber Lybert as Chair and Campaign Manager and Sid Gregory as Committee Treasurer. The C-1pc report was in effect for the remainder of 2014, all of calendar years 2015 and 2016, and January of 2017.
4. PDC staff queried the PDC contribution database and reviewed documents filed by candidates for public office, and staff found the Grant County Republican Party Central Committee (Committee) made, at a minimum, the following monetary contributions to candidates for public office for calendar years 2016 through 2019:
 - 2016 election cycle: The Committee made three contributions totaling \$1,500 in 2016 that included a \$250 monetary contribution to Secretary of State Kim Wyman's campaign committee and two contributions to the Washington State Republican Party totaling \$1,250.
 - 2018 election cycle: The Committee made a \$500 contribution to Casey Cooper, a candidate for Grant County Treasurer.
 - 2019 election cycle: The Committee made a \$1,250 contribution to the Kittitas County Republican Party and a \$300 contribution to LSPAC.org, an Eastern Washington candidate recruitment group.

5. On February 19, 2019, the Committee filed 13 C-3 and C-4 reports detailing contribution and expenditure activities undertaken during the 2017 election year and disclosing \$34,586 in total monetary and in-kind contributions received (\$0 in funds carried forward from 2016), and \$8,628.91 in total expenditures made. These reports were filed between 405 and 739 days late.
6. On May 8, 2019, the Committee filed 12 C-3 and C-4 reports detailing contribution and expenditure activities undertaken during calendar year 2018 election year and disclosing \$30,097 in total monetary and in-kind contributions received, which included \$7,815 in funds carried forward from 2017 and \$12,758 in total expenditures made. These reports were filed between 214 and 462 days late.
7. On July 12 and 15, 2019 the Committee attempted to file its missing reports from 2015 and 2016; however, even with assistance from PDC Filer Assistance, the Committee reported experiencing challenges filing those reports using the Online Reporting of Campaign Activities (ORCA) PDC software.
8. On August 13, 2019 (the date of this Notice of Administrative Charges), the Committee filed 10 reports detailing contribution and expenditure activities undertaken covering January 1 to July 27, 2015 and disclosing \$18,183.71 in total monetary and in-kind contributions received, which included \$4,845.71 in funds carried forward from 2014, and \$6,899.18 in total expenditures made. These reports were filed between 1,645 to 1,477 days late.
9. As of the date of this Notice of Administrative Charges, the Committee had not filed the missing C-3 and C-4 reports for August through December 2015 and calendar year 2016. The Committee had also failed to file the required 2018 7-day Pre-General Election C-4 report, a 2018 Post-General Election C-4 report, and a December 2018 C-4 report, as well as any C-3 reports for contributions received and deposited by the Committee during the period October 16 through December 31, 2018.

10. Most of the Committee's contributions received each year were from individuals that are Grant County Republican Party Officers, PCO's, members, and residents, along with the proceeds from an annual Lincoln Day Dinner auction and other low-cost fundraising events.
11. Most of the Committee's expenditures each year are for party building activities and administrative expenses, costs associated with the annual Lincoln Day Dinner, and the costs associated with local fairs and festivals.

Laws and Rules

RCW 42.17A.235 and **RCW 42.17A.240** require political committees to file timely, accurate reports of contributions and expenditures. Under the full reporting option, until five months before the general election, C-3 and C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report; on the twenty-first day and the seventh day immediately preceding the date on which the election is held; and on the tenth day of the first month after the election.

Report of Investigation

I. Background, Complaint and Allegations

- 1.1 The Grant County Republican Party Central Committee is a Bona Fide County Political Party Committee located in Moses Lake, Grant County, and has been registered and reporting with the PDC dating back to the 1990's.
- 1.2 On February 11, 2019, the Grant County Republican Party Central Committee (Committee) filed an amended Committee Registration (C-lpc report) as a Continuing Bona Fide Political Party Committee, selecting the Full Reporting Option and listing Rae A. Journey as Campaign Manager and Treasurer. The C-lpc report also listed Barbara Morgan as Chair, Arlin Hope as Vice Chair and Pat Weber as Secretary. **Exhibit #1.**
- 1.3 On February 2, 2017, Grant County Republican Party Central Committee filed a C-lpc report as a Continuing Bona Fide Political Party Committee, selecting the Full Reporting Option and listing Danny Stone as Chairman and Campaign Manager and Rae A. Journey as Committee Treasurer. The C-lpc report also listed Barbara Morgan as Committee Vice-Chair and Pete Knittle as Committee Secretary. **Exhibit #2.**
- 1.4 On February 11, 2014, Grant County Republican Party Central Committee filed a C-lpc report as a Continuing Bona Fide Political Party Committee, selecting the Full Reporting Option and listing Kimber Lybert as Chair and Campaign Manager and Sid Gregory as Committee Treasurer. The C-lpc report also listed Eric Hildebrand as Committee Vice-Chair, Casey Cooper as State Committeeman and Susan Freeman as State Committeewoman. **Exhibit #3.**
- 1.5 On November 7, 2018, David Hammond filed a complaint (**Exhibit #4**) with the PDC alleging that the Grant County Republican Party Central Committee violated:
 - RCW 42.17A.220 by failing to timely deposit monetary contributions received within five business days of receipt; and

- RCW 42.17A.235 and .240 by failing to file or timely file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contributions and Expenditures reports (C-4 reports) disclosing contribution and expenditure activities undertaken for calendar years 2015 through 2018.
- 1.6 On January 31, 2019, the PDC conducted an Initial Hearing (Case Status Review) and opened a Formal Investigation against the Grant County Republican Party Central Committee.
- 1.7 The Committee has no prior PDC violations but was issued a formal written warning letter regarding missing PDC reports in 2014.

II. Investigative Findings

- 2.1 Bona fide political party committees that were registered with the PDC during calendar years 2014 through 2018, selected the Full Reporting option, and participated in a primary and/or general election by: (1) making contributions or independent expenditures to support or oppose candidates or ballot propositions; (2) endorsing candidates or ballot propositions; or (3) making contributions to a political committee, including caucus and caucus-related political committee or political party organizations, were required to file the following C-3 and C-4 reports:
- All monetary contributions received by a political committee must be deposited into the committee bank account within five business days of receipt, and each committee is required to file one C-3 report for each bank deposit.
 - Monthly C-3 reports are due to be filed by the 10th of each month disclosing contributions received and deposited during the previous calendar month for the periods January 1 through May 31, and the day after the general election is held through December 31 of each calendar year. Beginning June through the day prior to the general election being held, weekly C-3 reports are required to be filed every Monday for contributions received and deposited during the previous five business days.
 - Monthly C-4 reports are required to be filed for the periods January 1 through May 31, and December 1 through 31, and are due to be filed by the 10th of the month if \$200 in contributions has been received or \$200 in expenditures have been made since the last C-4 report was filed.
 - A 21-day Pre-Primary Election C-4 report, a 7-day Pre-Primary Election C-4 report and a Post-Primary Election C-4 report for each calendar year.
 - A 21-day Pre-General Election C-4 report, a 7-day Pre-General Election C-4 report and a Post-General Election C-4 report for each calendar year.
- 2.2 State law requires political committees under the Full Reporting option to accurately file C-3 and C-4 reports disclosing contribution and expenditure information, including the name and address of each person to whom an expenditure was made in the aggregate amount of more than fifty dollars during the period covered by this report, the amount, date, and a detailed description or purpose of each expenditure, and the total sum of all

expenditures. In addition, PDC rules and reporting requirements require political committees to identify any candidate supported or opposed by an expenditure, and to provide the purpose and the goods or services provided by the expenditure.

- 2.3 PDC staff queried the PDC contribution database and reviewed documents filed by candidates for public office, and found the Grant County Republican Party Central Committee (Committee) made 11 monetary contributions to candidates for public office for calendar years 2012 through 2019, as follows:
- 2012 election cycle: The Committee made a total of \$1,000 in contributions to five 2012 candidates for public office and included \$200 to each of the following candidates: James H. Watkins, Richard B. Sanders, Clint B. Didier, Carol A. Swartz and Kim Wyman.
 - 2016 election cycle: The Committee made three contributions totaling \$1,500 in 2016 that included a \$250 monetary contribution to Kim Wyman and two contributions to the Washington State Republican Party totaling \$1,250.
 - 2018 election cycle: The Committee made a \$500 contribution to Casey Cooper, a candidate for Grant County Treasurer.
 - 2019 election cycle: The Committee made a \$1,250 contribution to the Kittitas County Republican Party and a \$300 contribution to LSPAC.org, an Eastern Washington candidate recruitment group.
- 2.4 The Committee failed to file any C-3 or C-4 reports for the 2015 or 2016 election years.
- 2.5 At the time the complaint was filed in November of 2018, no C-3 or C-4 reports had been filed for calendar year 2018, and only eight C-3 reports for calendar year 2017 covering the period January 1 through April 25, 2017 had been filed. Those eight C-3 reports totaled \$12,404 in monetary contributions received mostly as proceeds from the Lincoln Day Dinner, plus \$3,225 in funds carried forward from 2017. No C-4 reports had been filed for calendar year 2017.
- 2.6 On February 19, 2019, the Committee filed 13 C-3 and C-4 reports detailing contribution and expenditure activities undertaken during the 2017 election year and disclosing \$34,586 in total monetary and in-kind contributions received (\$0 in funds carried forward from 2016), and \$8,628.91 in total expenditures made. These reports were filed between 405 and 739 days late.
- 2.7 On May 8, 2019, the Committee filed 12 C-3 and C-4 reports detailing contribution and expenditure activities undertaken during the calendar year 2018 election year and disclosing \$30,097 in total monetary and in-kind contributions received, which included \$7,815 in funds carried forward from 2017, and \$12,758 in total expenditures made. These reports were filed between 214 and 462 days late.
- 2.8 On July 12 and 15, 2019 the Committee attempted to file its missing reports from 2015 and 2016; however the Committee reported experiencing challenges filing those reports using the Online Reporting of Campaign Activities (ORCA) PDC software.

- 2.9 On August 13, 2019 (the date of this Report of Investigation), the Committee filed 10 reports detailing contribution and expenditure activities undertaken covering January 1 to July 27, 2015 and disclosing \$18,183.71 in total monetary and in-kind contributions received, which included \$4,845.71 in funds carried forward from 2016, and \$6,899.18 in total expenditures made. These reports were filed between 1,645 to 1,477 days late.
- 2.10 As of the date of this Report of Investigation, the Committee has failed to file the 7-day Pre-General Election C-4 report, a Post-General Election C-4 report, and any C-3 reports for contributions received and deposited covering the period October 16 through December 31, 2018.
- 2.11 The chart below summarizes the contribution and expenditure activities, and timeliness of reporting, undertaken by the Committee for calendar years 2014 to present.

- 2.12 On December 10, 2018, Ms. Journey responded to the complaint on behalf of the Committee stating that the Grant County Republican Party is "an all-volunteer organization that reorganizes every 2 years pursuant to RCW 29A.80.030." **Exhibit #5.** She stated that the party, its Officers and members takes compliance with the PDC reporting requirements for a political party committee very seriously, and added she was elected Party Treasurer in December of 2016. She stated that prior to taking office as Committee Treasurer, she was trained by the previous party Treasurer, Lucinda West.
- 2.13 Ms. Journey stated that upon review of the complaint, the Committee's records, and the PDC laws, rules and reporting requirements for a committee "it appears that we may have some discrepancies as detailed in the complaint." She stated that her review found one instance in which the Committee failed to timely deposit monetary contributions within five business days of receipt and added that her "predecessor had told me I had 3 days to make the deposit and I strictly adhered to it."

- 2.14 Ms. Journey stated that upon reviewing the Committee's Online Reporting of Campaign Activities (PDC ORCA software) files and the Committee's C-3 and C-4 reports on the PDC website, "we (the Committee) may have some discrepancies as detailed in the complaint." She stated that the Committee entered contribution and expenditure information into the ORCA program, but did confirm no C-3 or C-4 reports were available on the PDC website.

III. Scope

- 3.1 PDC staff reviewed the following:

- The complaint and exhibits filed November 7, 2018 by David Hammond.
- Telephone conversations and email communications between PDC staff and Rae A. Journey, representing the Grant County Republican Party Central Committee.
- The PDC contribution and expenditure database for the Grant County Republican Party Central Committee.
- The PDC database for candidates or political committees reporting contributions from the Grant County Republican Party Central Committee.
- PDC reports filed in 2019 by the Committee. The reports were filed on February 11, February 19, March 11, March 13, April 10, May 8, May 9, June 10, July 9, July 12 and July 15.

- 3.2 Chronology of PDC staff's attempted contacts with the Committee concerning the complaint:

- Ten Emails and nine phone calls between Commission staff and Committee representatives between November 16, 2018 and July 31, 2019.

IV. Statutes

- 4.1 **RCW 42.17A.220** requires all monetary contributions received by a political committee to be deposited into the committee bank account within five business days of receipt.
- 4.2 **RCW 42.17A.235 and 240** require continuing political committees to file timely and accurate C-3 and C-4 reports disclosing contribution and expenditure activities undertaken by the committee. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report. Beginning June 1st for every political committees participating in an election, C-4 reports are required 21 and 7 days before each election in which the committee receives contributions or makes expenditures, and in the month following the election. Monetary contributions are reported weekly during this same time and are required to be disclosed on a C-3 report filed every Monday for monetary contributions deposited into the committee bank account the previous five business days.

I am writing in response to PDC Case #43080, a complaint filed by David Hammond against the Grant County Republican Party. I would like to ensure the Commission that we take compliance with the PDC very seriously. We are an all-volunteer organization that reorganizes every 2 years pursuant to RCW 29A.80.030.

I was elected Treasurer in December of 2016. Prior to taking office, I was trained by the previous Treasurer, Lucinda West. Upon review of the complaint, our organization's records, and the law and regulations, it appears that we may have some discrepancies as detailed in the complaint. I have gone through all finance records and have found allegation one, failure to deposit timely contributions to be unfounded. My predecessor had told me I had 3 days to make the deposit and I strictly adhered to it.

Upon reviewing ORCA and the PDC website, I have found that Allegation 2, failure to timely report contributions and expenditures. Reports were generated in ORCA but not available on the PDC website.

I will be reaching out to the Commission on Monday to find a solution as to why the reports are stuck in Que as I am suspecting.

I am looking forward to further dialogue of how we can rectify this situation so that moving forward we can be in full compliance.
