Subject: Complaint regarding Abbie Zulock, PDC Case 46636

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 2, 2019. Your complaint alleged that Abbie Zulock may have violated RCW 42.17A.605 by failing to submit a recent photograph for her lobbyist registration.

PDC staff reviewed your allegations and, as a result of staff's review, we found the following:

- Abbie Zulock (the "Respondent") is a registered lobbyist, employed by WA Public Employees Association, who failed to submit a recent photograph to the PDC as required per RCW 42.17A.605.
- The Respondent took corrective action and uploaded the missing photograph on March 25, 2019. Prior attempts to upload the photo were unsuccessful due to technical and account access issues.

Based on these findings, staff has determined that, in this instance, failure to submit a photograph for a lobbyist registration does not amount to an actual violation warranting further investigation.

PDC staff is reminding Abbie Zulock about the importance of submitting a recent photograph when registering as a lobbyist, maintaining current contact and lobbyist employer information with the PDC, and the timely filing of all future required lobbyist registration information.

The PDC has dismissed the matter and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
