To whom it may concern,

It has come to my attention that Kate Kruller has further violated Washington State's campaign finance laws (RCW 42.17A).

1) Actively campaigning, before filing "statement of organization" (C1). (Violation of RCW 42.17a.210(1))

State law requires each candidate, within 2 weeks after becoming a candidate, to file a statement of organization (C1) Kate Kruller filed with King County Elections, as a candidate for Tukwila City Council, during filing week (May 13th thru 17th 2019). As of the date of this complaint she has still not filed her C1, which is far beyond 2 weeks already and a clear violation of state law. This much was reported previously under my previous Complaint against this candidate (See **PDC Case # 52387**).

However, attached is evidence that she began her campaign as early as May 10, 2018, which means **she is actually over a year delinquent filing her C1 with the PDC**. Unfortunately, she is ignoring her obligation to provide the public with her campaign finance status. No one even knows if she will use Full-Reporting, or Mini-Reporting. Thus, the public is unable to monitor her campaign for compliance with state law. As an experienced candidate this reveals either a disdain for State Law, or a deliberate attempt to keep the public in the dark, or both.

- 1. Kruller began her campaign as early as May 10, 2018 when she renewed her domain name for her web site. See attached screen captures of WhoIs web page and her web site (http://www.kate4tukwila.com/), both dated 10/31/2018. This was nearly three years after her prior campaign completed in 2015, yet her web site was still alive and she renewed this domain name in preparation of her 2019 campaign.
- 2. On her current web site--in her own words--she is "out in the community again, doorbelling and talking to people in Tukwila..." See attached screen capture of her campaign web page dated 6/8/2019.
- 3. Because she has not reported any contributions or expenses for her 2019 campaign, we have no idea who designed her web site and what she expended to create it.
- 4. She is also soliciting endorsements and presumably contributions too. See attached screen capture of her campaign endorsement web page--with dozens of endorsements-dated 6/8/2019.

By violating **RCW 42.17A.210**--failing to declare her candidacy (C1)--we also don't know who is serving as her treasurer, nor has she begun filing either C3s or C4s, to document her campaign donations and expenses.

As an experienced long-term partisan politician she certainly knows better. Please don't hesitate to contact me if you need any additional information.


