Candidate has failed to file a single C-4 since announcing candidacy. Candidate maintains a treasurer other than herself according to the C-1, so a complete non-reporting is inexcusable. At a minimum, candidate filed for office for \$129 and this went unreported. Candidate displayed pictures of business cards on Facebook and reported no in-kind donation or expenditures. Candidate displayed pictures of headshot in February 2019, thanking donor of headshot, with no in-kind reporting. Candidate maintains a PayPal donation account; may have no C3 because she has no donations. At a minimum, business cards and filing fee for office need to be reported as to the source of these funds. I requested an F-1 to see if candidate maintains political account, but PDC has not returned that public records request.

What impact does the alleged violation(s) have on the public?

Candidate fails to adhere to open government & rudimentary campaign finance laws, without even an attempt to adhere to the law. Has filed zero C3/C4 reports while highlighting her expenditures, at minimum business cards, head shots, and a filing fee, on her candidate FB page. Candidate did simply not mis-report, under-report, but failed to report entirely, demonstrating a complete lack of understanding of WA open government law.
