

## Complaint Description

To whom it may concern,

It has come to my attention that Dan Satterberg during his 2018 campaign for King County Prosecutor violated Washington State's campaign finance laws (**RCW 42.17A**).

### **1) Accepting Illegal Over limit Anonymous Contributions (Violation of RCW 42.17A.220 (4))**

Dan Satterberg violated Washington State's campaign finance laws by accepting more than \$300 in anonymous contributions from donors. Specifically, it appears that he accepted \$1,223 in anonymous contributions, which is \$923 more than the allowable anonymous contribution limit defined in **RCW 42.17A.220 (4)**.

Upon reviewing the expenditures by candidate's political committee, there is no evidence supporting any claim these funds were eschewed to the Treasury of the State of Washington as is required in law. Therefore this is a violation of the statute, and these funds should be immediately forfeited to the Washington State Treasury.

I've attached the relevant C3 contribution report which detail all the anonymous contributions received by this committee during the 2018 calendar year. **This PAC must forfeit \$923 to the Washington State Treasury immediately.**

### **What impact does the alleged violation(s) have on the public?**

Anonymous secretive dark money should not be allowed to fund political candidates or campaigns. These funds should be immediately forfeited to the Washington State Treasury where they can be promptly squandered with the rest of the general funds. At least this will encourage candidates to avoid taking secret, dark money from anonymous sources...
