Subject: Fair Campaign Practices Code Complaint Concerning Linda Oosterman (7),  
PDC Case 54849

On July 15, 2019, the Public Disclosure Commission (PDC) received a complaint from Andrew Saturn, alleging a violation of one or more specific provisions of WAC 390-32-010, the Fair Campaign Practices Code (FCPC). The complaint concerned Linda Oosterman, a 2018 candidate for Thurston County Public Utility Commissioner.

The Campaign Fair Practices Code requires the PDC to forward the complaint to the party alleged to have violated the FCPC, request a response within five days, and then send the complaint and the response, if one is received, to news media. WAC 390-32-030 prevents the Commission and staff from commenting on the complaint or the response.

Attached with this memorandum are copies of the Complaint filed by Andrew Saturn, and the Response provided by Linda Oosterman. Any questions should be directed to Andrew Saturn or Linda Oosterman.

**Complaint Description**

Andrew Saturn (Sun, 14 Jul 2019 at 5:02 AM)

For ease of filing, I have attached a single PDF containing my allegations, summary, and evidence.

**What impact does the alleged violation(s) have on the public?**

Linda Oosterman has violated and eroded the public trust, removing confidence in our democracy, bringing embarrassment to the Thurston County Public Utility District, and encouraging additional ethical violations and unchecked plutocracy throughout our state.

I certify (or declare) under penalty of perjury under the laws of the State of Washington that information provided with this complaint is true and correct to the best of my knowledge and belief.

During her 2018 PUD campaign, Linda Oosterman, her campaign team, and various associates violated multiple sections of WAC Title 390 and RCW 42.17A, including but not limited to multiple violations of:

- A. 42.17A.305 failure to report and itemize electioneering communications
- B. 42.17A.310 failure to report suggested and/or requested in-kind electioneering communications
- C. 42.17A.235 failure to report other in-kind contributions
- D. 42.17A.335 making and encouraging false and defamatory statements
- E. 42.17A.555 using public resources to assist in an election campaign
- F. WAC 390-32-010 sections 1, 2, 3, 4, 6, 7 and 8 (all sections except 5)

## ALLEGATIONS

On May 16, 2018, I was invited to meet with Thurston Environmental Voters ("TEV") for a potential endorsement. At the meeting was TEV's chair, Danielle Westbrook, who at the time did not disclose that she was working for Percival Consulting, which had been hired to manage the campaign of my opponent, Linda Oosterman. I was later informed by members of the TEV board that after my departure from the meeting, Danielle Westbrook presented a purported transcript of a "criminal court case" in which I was allegedly "found guilty." Danielle Westbrook did not allow those in attendance to read the transcript. I was subsequently not endorsed by TEV due to their concerns of this alleged "criminal" case. Danielle Westbrook later, in an email to me (attached), first denied knowledge of any purported court transcript, and then later acknowledged "my position" on her sharing it. Aside from committing a personal ethical failure by not recusing herself, and then attempting to lie to cover her tracks, Danielle Westbrook, an agent for Linda Oosterman, violated RCW by spreading defamatory statements about a candidate, which she used to build a false narrative for future suggested and/or requested electioneering communications, and did not report this in-kind contribution. This is a violation of 42.17A.235, 42.17A.335, and 42.17A.310.

Between May 2018 and November 2018, Danielle Westbrook, listed on the website for Percival Consulting as a "principal," and later reported by Linda Oosterman herself as "part of the campaign team," spread (via email and Facebook) a transcript of a Dec 2017 civil court case in which I was the plaintiff seeking a protection order against individuals who had stalked and harassed my partner and me and threatened us with violence. This transcript was also sent to my supporters and used misleadingly and out of context to once again attempt to paint me as "having a criminal record," even though I was the plaintiff in the civil case. Thurston County Courts only provide audio transcripts; written transcripts must be purchased from 3rd party vendors.

According to a public records request, an audio transcript was requested from Thurston County Courts on May 22, 2018, by Riley Woodward-Pratt, co-chair of Olympia DSA. The written transcript says it was created on June 4, 2018. Holly Rydel Kelly, owner of the transcription service, stated in an email on Feb 28, 2019, that Deb Pattin, an Oosterman campaign team member, requested and paid \$325 for the transcription. This transcript and the associated costs to produce it were not reported as a direct expenditure or in-kind contribution. The electioneering communications of Percival Consulting's Danielle Westbrook, in sharing this transcript, were also unreported. These are violations of 42.17A.235, 42.17A.335, and 42.17A.310.

In early July, 2018, my campaign was removed from our shifts at the Thurston County Democrats "Burger Booth" at Lake Fair after Mary Hall stated to booth manager Ryan Campbell and other local elected officials and candidates, that I "was not a real Democrat." Many of them threatened to change shifts to avoid being seen with me or my campaign. When I contacted Ryan Campbell by phone for clarification, he said that Mary Hall stated I was "running against a Democrat," which was also not true. Follow-up emails sent by Mary Hall's campaign manager, Rob Richards, on behalf of Mary Hall, claimed I am "toxic and abusive," and stated without evidence that "women don't feel safe" around me. Rob Richards claimed without evidence that "over a dozen women from Spokane have come forward with stories of bullying, manipulation and harassment." I have never even set foot in Spokane.

According to Linda Oosterman, Mary Hall was a member of Linda Oosterman's "campaign team." These defamatory electioneering communications were made on behalf of Linda Oosterman, and violations of 42.17A.235, 42.17A.335, and 42.17A.310.

During a Burger Booth shift at Lake Fair the week of July 9, 2018, I watched as my campaign literature and signs were repeatedly taken from the Democrats booth and moved to the Republican "hot dog" booth, or thrown in the trash, by individuals such as Sarah Rawlings, Mike Tobias, and Florence Vincent. These individuals were all supporters and agents of Linda Oosterman (Sarah Rawlings and Mike Tobias represent Thurston County Young Democrats, which was the only Democratic-affiliated organization in the county to endorse Oosterman). These individuals also posted photos of my literature next to Republican literature on Facebook to imply that I am a Republican. These defamatory statements were an organized smear and were done to attack my campaign, and prevent my campaign from being seen at a Democrats event, implying to the public that my campaign is not the Democrat-endorsed campaign. Linda Oosterman had not attended a single Democrats meeting or event in 2018, was not qualified for an endorsement, and did not seek an endorsement. These defamatory electioneering communications were made on behalf of Linda Oosterman, to damage my Democratic party endorsement, and were violations of 42.17A.235, 42.17A.335, and 42.17A.310.

On July 10, 2018, in response to an email I sent to Mary Hall asking about her defamatory statements about my campaign, Mary Hall retaliated by contacting Chip Beatty at the PDC, who shared with me via telephone that Mary Hall had made a false complaint that I was "sending promotional campaign communications to everyone at the auditor's office." When pressed for evidence of these claims, Mary Hall retracted them. Mary Hall later told various elected officials and local activists that I "harass her" and "call her incessantly," which is also false and defamatory since it implies that any candidate-to-auditor communications are personal in nature, and not a requirement of candidates running for office. These electioneering communications from an elected official and agent of my opponent, Linda Oosterman, were defamatory, and a violation of 42.17A.335.

On July 23, 2018, at the annual "Karen Fraser Picnic," Linda Oosterman and campaign associates, including Thurston County Auditor Mary Hall, confronted many of my supporters and told them that I am "a liar," "abusive," "harassing women," and "a criminal." My supporters, endorsers, and others were encouraged to stop supporting me and to spread this false information. These are violations of 42.17A.335 and 42.17A.310. See email from Thurston County Conservation District Commissioner Paul Pickett who had endorsed my campaign, informing me that Linda Oosterman personally made these false statements to him.

On July 23, 2018, at the very same event, a campaign staffer and I were physically assaulted and harassed by two intoxicated individuals, Deb Pattin and her husband Robert Pattin, while they were working for Linda Oosterman's campaign. Robert Pattin knocked over my campaign's table and signs, slapped me, knocked me to the ground, and broke my phone when I attempted to record his behavior. This was witnessed by my campaign staffer as well as various other individuals at the event, and documented by videos and photos. Deb and Robert Pattin went on to continue to stalk and harass my campaign team and me, and eventually attempt to block my campaign team and me from leaving the event. Deb Pattin was shouting that I'm a "liar" and a "criminal." A Tumwater Police report (#182040794) was filed regarding the assault. I decided against filing charges, since Robert Pattin is over 70 years old and was very intoxicated at the time, and has a prior criminal past related to alcohol. I do not believe spending the night in jail would be helpful to his problems.

At the September 26, 2018 endorsement meeting of the Thurston County Democratic Women (TCDW) at Olympia Center, Susan Herring (acting chair) stated I am a "criminal" and cited the transcript supplied to her by Linda Oosterman's campaign managers (namely Deb Pattin and Danielle Westbrook of Percival Consulting) as evidence. Susan Herring did not allow me to rebut her defamatory statements. I was then grabbed and forcibly removed from the room by individuals twice my size when I attempted to deliver the statement I was invited to the event to share. I later learned that the TCDW had already voted to endorse my opponent, and many members of their executive

committee were either working for my opponent's campaign and/or for the pro-Oosterman PAC "Up for Thurston County." My invitation to the event was apparently under false pretenses so that I could be publicly attacked in front of potential supporters without an opportunity to respond. This event served as an electioneering communication, and the false statements spread at this event at the direction or suggestion of Linda Oosterman, her agents, and her associates, were not reported as in-kind contributions. This is a violation of 42.17A.235, 42.17A.335 and 42.17A.310. Evidence that I attended this event can be seen in a separate complaint, #47222.

At the October 10, 2018 Thurston Chamber Candidates Forum, Linda Oosterman confronted Lacey City Councilmember Carolyn Cox after seeing her and I sharing a conversation about fellow candidate Tye Menser (for which Carolyn was a campaign volunteer). I overheard Linda Oosterman say, without any specific examples, "How can you talk to him, he's a liar! All he does is lie!" This was confirmed to me by Carolyn Cox, and further illustrates that Linda Oosterman herself was directly involved in spreading defamatory statements about me, and encouraging others to spread these statements, while not reporting the resulting electioneering communications as in-kind contributions. This is a violation of 42.17A.335 and 42.17A.310.

On October 12, 2018, Joe Hyer submitted PDC complaint #41577, alleging that I was "lying" about Linda Oosterman, and that I violated other sections of RCW 42.17A (allegedly failing to report expenditures and allegedly failing to report my filing fee, among other inaccurate grievances). The PDC determined that I was not making false statements, and that I did not violate any other sections of RCW 42.17A, and dismissed the other dozen or more complaints entirely. Joe Hyer filed these frivolous complaints as an individual, stating under penalty of perjury that he had no connection or direction from Linda Oosterman. However, Joe Hyer was later found to have been working for Linda Oosterman via his consulting firm Percival Consulting at the time of his complaint being filed (see various attached emails and invoices provided by Joe Hyer). The complaints were used as electioneering communications, and were filed with the intention of weaponizing the PDC complaint process for the benefit of Linda Oosterman's re-election campaign, and creating a false narrative that my campaign was in violation of state law, or making false statements about Linda Oosterman, when both were not the case. The false statements in Joe Hyer's complaints were used as arguments against my endorsement at Thurston County Democrats endorsement meetings, and at other events and meetings, to attack my campaign and my reputation. Even though Joe Hyer invoiced Linda Oosterman's campaign for thousands of dollars for the work he and his firm performed, including filing these complaints, these complaints were never reported as in-kind contributions by Linda Oosterman. These complaints (electioneering communications) also contained false and defamatory statements about a candidate. Aside from being perjury, this is a violation of 42.17A.235, 42.17A.335 and 42.17A.310.

On October 13, 2018, Deb Pattin sent an email to a supporter of mine, Sherri Goulet, with the "internal memo" written by PUD General Manager John Weidenfeller (see PDC complaint # 43061). Mr. Weidenfeller has stated that he didn't share the memo. A campaign staffer for Linda Oosterman sharing the PUD "internal memo" fewer than 24 hours after it was written in an attempt to attack my campaign is a clear violation of RCW 42.17A.555.

On Oct 18, 2018, I was invited to and attended a candidate forum in Lacey. My opponent, Linda Oosterman, told the moderators, Elizabeth Catterson and Troy Kirby, that I was "harassing her," and implied that she would need physical protection during the forum. Not only has Linda Oosterman never had a conversation with me, but before I declared I was going to be a candidate, Linda Oosterman never responded to the single completely reasonable constituent email I sent about PUD policies and decisions. Additionally, Linda Oosterman and her campaign never responded to my respectful requests to meet, to have debates, to inspect books, etc. Linda Oosterman and I have never had a single conversation, and I was in no way "harassing her." This statement was a false and defamatory electioneering communication, and an attempt to maliciously damage my reputation, and was not reported, which is a violation of 42.17A.335 and 42.17A.235.

On Oct 19, 2018, my campaign staff witnessed an individual, believed to be a known Linda Oosterman supporter and volunteer driving around in West Olympia, picking up and stealing my campaign yard signs from private property.

When my staffers confronted the individual, he sped off in his truck. They followed in order to get his license plate number, but the individual began to speed and drive erratically, and so my staffers stopped following. This was reported to Olympia Police (report #182930335), and the investigation and any charges are still pending. Over the course of my campaign, we distributed at least 200 yard signs. Fewer than 20 were recovered. This individual was likely acting on behalf of my opponent, Linda Oosterman, responding to the misinformation and defamatory statements she was sharing about me and my campaign. The individual's actions were an attempt to elevate Linda Oosterman's public presence, which is an in-kind contribution, and was not reported. I reached out to Linda Oosterman and asked her to communicate to her people to stop stealing my yard signs, and did not receive a response. Aside from being theft, this is a violation of 42.17A.235.

On Oct 20, 2018, at the Olympia PFLAG Candidates Forum, Linda Oosterman was spreading a so-called "internal memo" to potential supporters as well as candidates, claiming I am a "liar" and that "all I do is lie." Linda Oosterman can be seen on video of the event (<https://youtu.be/8WB9cwtVuPM?t=68>) showing Bud Blake this "internal memo" which she stored inside of a blue envelope. The PUD uses blue envelopes, and Linda Oosterman using this memo and this envelope for her campaign is a violation of RCW 42.17A.555. Calling me a "liar" based on her disagreement with my math is a defamatory statement and a violation of RCW 42.17A.335.

On Oct 26, 2018, Renata Rollins, current Olympia City Council member, created a Facebook post full of defamatory false statements and misinformation (including claims that I am "an operative, a misogynist, unaccountable, an abuser, fraudulent, a bully, a harasser, an intimidator, a humiliator, a punisher, a retaliator, cruel," and others). Renata falsely claims I "target trans and queer individuals and women specifically," and offers zero details or evidence. Renata, encouraged by Linda Oosterman and associates, wrote this post with the intention of attacking my campaign, me personally, and my relationship with my partner. This has cost me a friendship, as while Renata claims in her post to have "watched me for months," she was at my house for a knitting night social event a short time before writing her post, apparently totally forgetting what a bad person I am. Additionally, I worked in 2017 to help elect Renata Rollins to Olympia City Council, and was part of a small group serving as her unofficial advisory committee post-election. I also worked directly with Renata early in her Councilmember days on topic of affordable housing. The false statements in Renata's post were spread to an unknown number of voters via Facebook, damaging the reputation of my campaign, myself, and my partner. The post was encouraged by the defamatory statements and misinformation spread by Linda Oosterman, making the post an unreported electioneering communication. This post was also never reported as an in-kind contribution. This is a violation of 42.17A.235, 42.17A.335 and 42.17A.310.

On Oct 30, 2018, Lisa Parshley made a Facebook post where she cites that she is a "survivor," and calls me an "abuser" and a "bully," implying without any specific claims or evidence that I have committed some sort of physical assault against women. This post comes on the heels of my informing her that I would not feel comfortable using her "house" at 1014 4th Ave E., Olympia, WA 98506 for a base of operations for my campaign. In addition to the fact that it was already being used by my opponent, it would damage my campaign: the building also serves as the location where Lisa Parshley and her husband are fraudulently registered to vote, even though they live in Boston Harbor, which is outside of Olympia city limits.

The office building has no bedrooms, kitchens, or showers. The building is wired with conference phones and contains nothing but office furniture. This building was actually used strictly as an office by myself and others on a daily basis for various local 2017 Democratic campaigns, including the campaigns for EJ Zita, Renata Rollins, and Lisa Parshley. During the 2017 campaign, I often worked late into the night, but I never once saw Lisa Parshley there. After Lisa Parshley realized that I knew she and her husband have been committing felony voter fraud, she also made false statements that I "threatened" and/or "assaulted" her, directly to my supporters, following pressure from Linda Oosterman to not support me or my campaign. In addition to the in-kind donation of the use of the building for Linda Oosterman's campaign, Lisa's defamatory electioneering communications via text, defamatory statements to voters, and defamatory Facebook post were never reported as in-kind contributions. These are violations of 42.17A.235, 42.17A.335 and 42.17A.310.

On Oct 30, 2018, Jim Cooper, current Olympia City Councilmember and chair of the city's finance committee, calls me a "dirtbag" via a hashtag on his Facebook post in which he was sharing Renata Rollins' and Lisa Parshley's Facebook posts (referenced above). Jim Cooper, who is the subject of the article "pitchman for convicted felon Joe Hyer's securities fraud" ([South Thurston Journal article dated 2/16/2017](#)) referred to Renata Rollins and Lisa Parshley (who is committing felony voter fraud) as "two of the most honest and forthright people you'll ever meet." Jim Cooper's defamatory electioneering communications, seen directly by at least 20 individuals and shared with an unknown number, were not reported as in-kind contributions. This is a violation of 42.17A.235, 42.17A.335 and 42.17A.310.

There are dozens of other outrageous smears and rumors these individuals spread about me during the campaign, ranging from "impersonating a union" to "stealing the Thurston County Democrats' mailing permit." There are simply too many to address here, and I am leaving the majority of them out for the sake of brevity.

November 5, 2018, the day before the election, one individual supporter of my opponent, and a member of Thurston County Democrats with access to the email blast system, sent out an unauthorized email claiming that my "behavior" is of concern, and TCD is "distancing itself" from my campaign. This was sent to imply I was no longer endorsed by the body of Thurston County Democrats, in a desperate and malicious attempt to affect the outcome of the election for the benefit of Linda Oosterman. My endorsement was never rescinded. Every TCD member involved in sending this email (many of whom were also involved with the pro-Oosterman PAC "Up for Thurston County sponsored by Puget Sound Energy") has since resigned in an attempt to avoid legal accountability. This message was sent to every member of Thurston County Democrats (including me), as well as anyone who has ever been a member, on behalf of Linda Oosterman, and was not reported as an in-kind contribution. This is a violation of 42.17A.235 and 42.17A.310. Additionally, the false statements shared are a violation of 42.17A.335.

## **SUMMARY**

I have never been arrested, detained, investigated, or accused of any sort of threats, harassment, assault, stalking or other inappropriate behavior or crimes by anyone. My entire life, I have used my privilege to stand up for women, minorities, oppressed people, kids, and our environment. I come from a working-class background, and understand what it's like to struggle with finances and have to work multiple jobs to get by.

Since the late 90s, I have been involved in movements to raise the minimum wage, get money out of politics, as well as presidential campaigns seeking to make a positive material change in society through empowering workers and class consciousness. As anyone at the PDC can confirm, I am a longtime advocate for transparency in government. In 2016, I was widely known as a "progressive leader" in politics in Seattle. I was interviewed on local television and radio stations and featured in articles in The Seattle Times, The Stranger, and other publications.

Unfortunately, after my 2018 campaign, my reputation has been damaged by the false statements and lies spread by individuals closely associated with my former opponent, Linda Oosterman, and her campaign. Many of these individuals are elected officials, and unlike me, many have public records showing a history of criminal convictions, charges for abuse and assault, fraud, and other serious crimes.

Linda Oosterman, her campaign staff, consultants, and associates ran an embarrassing, disgusting and shameful campaign with zero ethical values or regard for meeting public expectations for transparent campaign reporting. While the violations outlined in this complaint may not be major reporting violations, they illustrate a pattern of Linda Oosterman and her campaign team habitually disregarding the state's laws and rules surrounding transparent campaign finances, and putting far more effort into co-opting and weaponizing the language of survivors with false claims of "abuse." This was all done in an effort to set off a domino effect of baseless smears and attacks against

my campaign, as well as attack the personal lives of my partner and me, in complete disregard and violation of the Fair Campaign Practices Code, as outlined in WAC 390-32-010.

Linda Oosterman and her campaign refused to attend a single debate, and instead spent a majority of their time attacking my campaign and attacking me personally. As shown in this complaint, Linda Oosterman, her campaign, and her associates concealed tens of thousands of dollars worth of electioneering communications and in-kind contributions. When taken into consideration in addition to the nearly \$25,000 in "independent" expenditures by PACs (run by her close friends, and funded primarily by Puget Sound Energy) in both her 2018 and 2012 campaigns, it would have been of vital importance for the public to have had access to this information early in the election season, or at least before the end of the election in November, 2018.

Linda Oosterman's disgraceful campaign for Public Utility District Commissioner, run primarily as a negative campaign, severely impacted my campaign and my personal reputation in Thurston County. I was a candidate who was seeking to materially improve the lives of county residents, protect the environment, and move us to renewable green energy. Linda Oosterman's campaign was ostensibly run for one purpose only: to protect Puget Sound Energy and their billion-dollar monopoly.

The public has been deprived of vital campaign finance and candidate information by these violations, and by the unethical behavior of Linda Oosterman, her campaign, and her associates. This type of behavior and involvement of corporate cash and influence weakens our democracy and should be strongly discouraged. I urge the PDC to pursue all investigatory and enforcement actions available under state law in relation to the allegations leveled herein. Linda Oosterman should not be given the opportunity for a typical "no offenses within five years" stipulation, as her term is six years, and she would be unable to re-offend within that time period unless running a campaign for a different elected office.

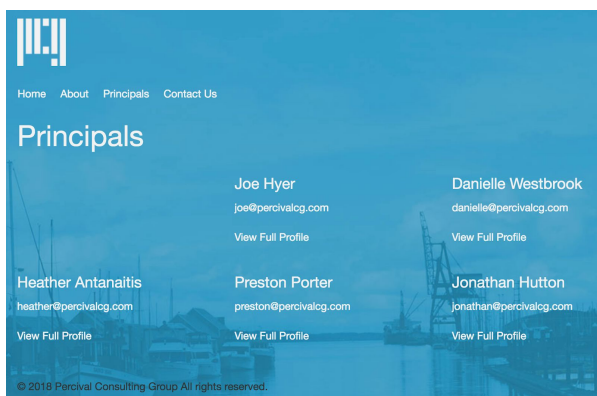

Mary Hall complained that you called her incessantly and she had to tell you to stop.

Emails dated July 23-24, 2018 from Paul Pickett, Thurston County Conservation District Commissioner, alerting me to the fact that Linda Oosterman and "others" were making defamatory comments and encouraging the spread of them at the Karen Fraser picnic earlier that evening. These include the false allegations that I "have a criminal record" and that I am "harassing women."

Other verbal reports I received indicated that Thurston County Auditor Mary Hall was among the other individuals spreading these defamatory statements.

Prior to my campaign, as part of my activism, I made pro-environmental public comments at the Port of Olympia's public meetings throughout 2017. I also worked for the campaigns of EJ Zita and Bill Fishburn.

Deb Pattin is on record in public comments for Port of Olympia as opposing pro-environmental policies.

I believe this is what had driven Deb Pattin to oppose my PUD campaign, and work for Linda Oosterman.

Throughout 2018, Deb Pattin was spreading both court transcripts as well as the Thurston PUD "internal memo" in an attempt to attack my campaign and spread defamatory statements about me on behalf of and for the sole benefit of Linda Oosterman.

TLMLC and all of it's members.

The Thurston County Democratic (TCD) party believes strong ties between labor and our party are essential to having our government fight for the working class and for all of our citizens. This belief is deeply entrenched in our core party value of supporting "economic justice for all." Candidates must go through a rigorous process before receiving our endorsement, including an application, an interview, two votes from our campaign services team, and two votes from our body. Throughout the process, candidates are asked questions to ensure that they support the platform of our party and the interests of labor.

Both Fishburn and Zita have demonstrated an unwavering desire to not only maintain the number of union jobs already at the Port of Olympia, but to also create additional union jobs and family-wage jobs through Port projects and investments. They both support integrating apprenticeship utilization language and responsible bidder practices in Port contracting. They both show strong opposition to "right-to-work" initiatives and strong support for prevailing wage requirements. Additionally, both have spoken loud and clear about support for a blue/green alliance, one that uses the development of a renewable energy future to create more jobs for local labor. Finally, both come from union backgrounds: Fishburn's parents are both union, his wife is union, and his grandfather started a steelworkers union in Spokane, while Zita is a union member herself.

We are writing to make it clear that the TCD exclusively supports Bill Fishburn and Zita for their respective Port Commissioner races. At our last central meeting of PCO's and our members, we voted overwhelmingly (over 95%) in support of endorsing them both. This came despite a motion from one member who tried to pull them from the slate of candidates claiming that Fishburn and Zita do not support labor. That motion to not endorse them with the rest of our slate fell flat. Not one member was willing to speak for the motion, while three members stood up and spoke strongly against the motion and in favor of endorsing Fishburn and Zita.

In conclusion, we are concerned that the endorsements of Fishburn and Zita are being withheld based on what we know to be false accusations coming from one person who is a member of our party. We need Fishburn and Zita in the Port of Olympia. We need more union jobs at the Port, we need a Port that will work for a future for all of us, and we need a Port that understands the value of responsible bidder contracts, apprenticeships, and prevailing wages. 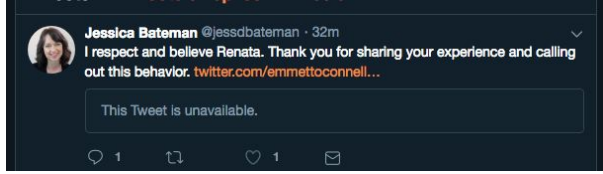

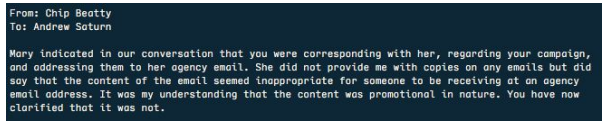

I've cc'd members of the TCD E board because I don't feel you're handling this situation properly and I'd like them to weigh in.
