- Alleged failure to timely & accurately file Personal Financial Affairs Statement (F-1 report):
  - o Report due within two weeks of announcing candidacy on 3/6/19
  - Not reporting relationship and/or ownership interest with three small companies mentioned in campaign materials
- Alleged failure to timely & accurately report expenditures on C-4 reports:
  - o Candidate filing fee
  - 5/3/19 Lincoln Day Dinner expenditure of \$75 (possible in-kind contribution)
  - o 6/17/19 contribution of \$250 made to Benton Co Republican Party\*

My responses: With respect to the F1 filing date, correct, I did file my long form late. My apologies. I am a first time candidate and was ill-prepared for filing a long form. As soon as I was made aware of the F1 and it's requiirements, I immediately went to gather all of the information so I could be as accurate as possible. I am a working mother of 3, so it took a while to get my mortgage records and tax information together. Again, my apologies, all of my other reports have been on time, and it will not happen again in the future.

I did report the required information on my dividend. The term I use is "stakeholder" which is a very broad term; I have a stake, or interest, in 3 local businesses.

I was not a candidate when I filed, my filing fee was a personal expense.

I had no Lincoln Day Dinner expenditures, my ticket was purchased for me.

My Treasurer, Charlotte Benjamin, previously responded to you regarding the Benton County expenditure. Please confirm receipt of her clarification.
