Subject: Complaint regarding Darcy Burner (Friends of Darcy Burner), PDC Case 55267

Dear Mr. Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on July 17, 2019. Your complaint alleged that Darcy Burner, a Candidate for State Representative in Legislative District 5 in 2016, may have violated RCW 42.17A.220(4) for accepting over limit anonymous contributions.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by Jason Bennett, Treasurer; the applicable PDC reports filed by Respondent; and queried the Respondent's data in the PDC contribution and expenditure database], to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- On February 23, 2016, Darcy Burner filed a Candidate Registration (C-1 report), declaring her candidacy for State Representative in Legislative District 5 in 2016, choosing the "Full Reporting" option, and listing Jason Bennett as Treasurer.
- RCW 42.17A.220(4) states in part that "accumulated unidentified contributions ..., in excess of one percent of the total accumulated contributions received in the current calendar year, or three hundred dollars, whichever is more, may not be deposited, used, or expended, but shall be returned to the donor if his or her identity can be ascertained. If the donor cannot be ascertained, the contribution shall escheat to the state and shall be paid to the state treasurer for deposit in the state general fund."
- On its website, PDC guidance outlines the amount of anonymous contributions a candidate campaign may accept in a calendar year.
- The complaint alleged that in calendar year 2016, the Friends of Darcy Burner campaign accepted anonymous contributions in the amount of \$336, which was \$36 more than the allowable limit of \$300.
- In his response, Mr. Bennett stated that on the final C-4 report submitted on November 9, 2017 covering October 1 to October 31, 2017, the Burner campaign disclosed an aggregate total of cash and in-kind contributions of \$206,750.89, which allowed the campaign to accept more than \$300 in anonymous.
- Staff's review of the Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports) filed by Friends of Darcy Burner found the campaign could accept the greater amount of up to 1 percent of the total accumulated contributions.

Based on these findings, staff has determined that, in this instance, no evidence supports a finding of a violation warranting further investigation.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
