Subject: Complaint regarding People for Moon, PDC Case 55460

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on July 25, 2019. Your complaint alleged that People for Moon may have violated RCW 42.17A.240 and WAC 390-16-037 by failing to accurately describe an expenditure on its C-4 report.

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by People for Moon (the "Respondent"); and the applicable PDC reports filed by Respondent to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- The Respondent is a single-year election committee that registered with the PDC on October 11, 2017.
- The Respondent filed a C-4 report (Summary, Full Report Receipts and Expenditures) on October 31, 2017 wherein it reported a \$25,000 expenditure to WinPower Strategies for "Political-Digital advertising" (report 100797247).
- On August 20, 2019, the Respondent amended its C-4 report to include additional details regarding the Political-Digital advertising expenditure (report 100925506).
- In its response, the Respondent indicated its belief that the original C-4 report met PDC reporting requirements. The Respondent nonetheless amended its report to facilitate transparency.

Based on these findings, staff has determined that, in this instance, failure to fully describe an expenditure on a C-4 report does not amount to a violation warranting further investigation.

People for Moon PAC made minor or ministerial errors on required reports, which did not materially impact the public interest. Upon notification of these errors, People for Moon PAC timely amended their reports, making the necessary technical corrections.

PDC staff is reminding People for Moon about the importance of fully and accurately describing expenditures on C-4 reports.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
