Subject: Complaint regarding Ashkan Amouzegar, co-owner of Lynnwood Forward, PDC Case 55605

Dear Marylou Eckart, Charles Eakins and Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaints you filed July 11, 2019 through July 16, 2019. Your complaints alleged that Ashkan Amouzegar, co-owner of the slate website Lynnwood Forward, may have violated RCW 42.17A.320 by failing to identify sponsors on political advertising (e.g. the Lynnwood Forward website).

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; and the response provided by Ashkan Amouzegar (the "Respondent") to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- Lynnwood Forward, is a slate¹ website co-owned by three first-time candidates for Lynnwood City Council (Nicholas Coelho, Ashkan Amouzegar and Naz Lashgari), all of which are registered as candidates with the PDC. The website is a cost-sharing measure and each candidate was billed and paid separately for web design work from their respective bank accounts. Lynnwood Forward's Facebook page is run under Nicholas Coelho's Facebook account.
- The Respondent registered with the PDC as a candidate on May 16, 2019 and selected the minireporting option. As a mini-reporter, the Respondent is not required to file monthly and weekly reports of deposits, contributions & expenditures with the PDC pursuant to RCW 42.17A.235 & .240.
- Pursuant to RCW 42.17A.320, all written political advertising shall include the sponsor's name
 and address, which must 1) be set apart from other printed matter; 2) appear on the first page of
 the advertisement or communication; 3) be in at least 10-point type or 10% of the largest type
 used in the advertising, whichever is larger; and 4) not be subject to a half-tone or screening
 process. RCW 42.17A.005(46(a) defines "sponsor" as the person paying for the political
 advertising.

¹ A "slate" is a group of candidates that run in multi-seat or multi-position elections on a common platform.

- When the complaints were filed in mid-July, the candidates that sponsored of the Lynnwood Forward website were not clearly identified on the political advertising (website) as required under RCW 42.17A.320. As a result, the public was unable to ascertain who funded the website. After being notified of the missing sponsor identification, the co-owners updated the Home and Candidate pages of the website to include each sponsor's name and address; this information was added to the website sometime between 7/26/19 - 8/2/19.
- As Lynnwood Forward is a website and therefore cannot violate RCW 42.17A.320, the obligation
 to disclose sponsor ID lies with the candidates who sponsored the political advertising (website).
 Please note:
 - The original complaint allegations against Lynnwood Forward were addressed in PDC Case 54873; and
 - Separate cases were opened to address the alleged violation of RCW 42.17A.320 by Nicholas Coelho and Naz Lashgari; these case numbers are 55603 and 55606 respectively.

Mitigating factors in this case include: The Respondent's status as a first-time candidate; noncompliance was the result of a good-faith error or omission for which the Respondent quickly took corrective action; and the relatively small size of the Respondent's campaign.

Based on these findings, staff has determined that, in this instance, failure to identify the sponsor on political advertising does not amount to a violation warranting further investigation.

PDC staff is reminding Ashkan Amouzegar about the importance of timely & accurately identifying and disclosing the sponsor on all political advertising, including campaign websites.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
