

**Complaint Description**

I received an email from the PAC "People for Seattle" to my private email address. I have never opted-in to emails from this PAC nor have I ever contacted this PAC or its members in the past. The only explanation for this PAC having my email address is that they purchased some sort of email list from a 3rd party vendor. This expense is not reported in their PDC filings, and it has been over 5 days since the mailing was sent. The email was sent using actionnetwork.org. This expense is also not listed in their filings. The email includes links which utilize SendGrid. This expense is also not listed in their filings. These electioneering communications are unreported. Sending campaign fundraising emails fewer than 21 days before an election and not reporting it is very deceptive and a clear violation of RCW 42.17A.260, and possibly other sections. If the PAC responds that this falls under "consulting," and that Dewey Square Group performed "consulting" for this campaign advertising, it is still a violation. RCW 42.17A.260 sections (3)(c) through (3)(f) are clear in that electioneering communications over \$1000 must be explicitly reported with details, and cannot simply fall under some sort of blanket description such as "consulting" or "advertising." This PAC did not disclose how many messages were sent, when they were sent, how they were sent, etc. This PAC has spent over \$50,000 and has not disclosed any of their advertising purchases as required by various sections of RCW 42.17A. It has been both 5 days since their advertising was sent or made available to the public, and it is fewer than 21 days from the primary election. This is a major violation of state law.

**What impact does the alleged violation(s) have on the public?**

Concealing expenses and amounts from the public.
