Staff expects you to timely file C-1 reports in future years in accordance with PDC laws and rules. The Commission will consider this formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Subject: Complaint regarding Drayton Jackson, PDC Case 55719

Dear Robert Parker:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on July 27, 2019. Your complaint alleged that Drayton Jackson may have violated RCW 42.17A.205 by failing to timely register as a candidate within two weeks of declaring candidacy by filing a C-1 report (Candidate Registration) containing, among other things, the campaign's Treasurer and depository (banking institution).

PDC staff reviewed your allegations; the applicable statutes, rules, and reporting requirements; the response provided by the Respondent; and the applicable PDC reports filed by Respondent to determine whether they support a finding of one or more violations.

Based on staff's review, we found the following:

- The Respondent is a first-time candidate for election to School Director for Central Kitsap School District who filed with Elections as a candidate on May 14, 2019.
- Candidates are required to register with the PDC within two weeks of becoming a "candidate," as defined in RCW 42.17A.005(9) and WAC 390-05-200. Pursuant to RCW 42.17A.205, candidate committees are required to register with the PDC within two weeks of 1) being organized; or 2) first having the expectation of receiving contributions or making expenditures, whichever comes first. The Candidate Registration (C-1 report) serves the dual purpose of registering both the candidate and the candidate's committee.
- The PDC notified the Respondent of the missing Candidate Registration (C-1 report) by email on August 6, 2019.
- The Respondent filed a C-1 report with the PDC on August 20, 2019 and selected the mini-reporting option. Mini-reporters are not required to submit C-3 and C-4 reports to the PDC disclosing campaign contributions and expenditures.
- The Respondent indicated he was not aware of the requirement to register with the PDC until June 26, 2019 and promptly filed a Personal Financial Affairs Statement (F-1 report). He erroneously believed the F-1 report satisfied his reporting requirements as a candidate.

- Aggravating factors include: The Respondent's late report was received 14 days after the Primary Election.
- Mitigating factors include: The Respondent is a first-time candidate with limited filing experience. The Respondent's late report was the result of a good-faith omission. The Respondent's campaign is relatively small and unsophisticated.

Based on these findings, staff has determined that, in this instance, failure to timely file the Candidate Registration (C-1 report) does not amount a violation warranting further investigation.

Pursuant to WAC 390-37-060(1)(d), Drayton Jackson will receive a formal written warning concerning his failure to comply with the filing requirements noted above. The formal written warning will include staff's expectation that Drayton Jackson timely file C-1 reports in future years in accordance with PDC laws and rules. The Commission may consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
