

## Complaint Description

To whom it may concern,

It has come to my attention that the Evergreen Health Foundation has committed various violations of Washington State's Campaign Finance Laws (**RCW 42.17A**). This Foundation was involved in supporting the large \$345 million bond for the public hospital district in Eastern King County. These violations are detailed below.

### **1) Failure to register as an "Incidental Committee" (Violation of RCW 42.17A.207)**

With the passage of the Disclose Act by the Washington State legislature, non-profit organizations like this must formally register with the PDC and disclose their top 10 contributors. However, nowhere can this information be discovered or found on the PDC's website. It appears this Foundation has failed to comply with the law. This is a serious violation, and even if this information is provided late (after receiving complaints), it does not change the fact this information was lacking during the recent political campaign season. It should be noted that this non-profit donated a massive amount of funding to support a ballot proposition (\$735,000). This was not a small organization or group of ignorant activists. They had ample funding to hire competent campaign staff, compliance staff, and already pay legal teams to manage their operations.

### **2) Failure to disclose top 5 contributors in electioneering communication (Violation of RCW 42.17A.320 (2)(b), and RCW 42.17A.320(6))**

This non-profit also produced at least one mailer within a few weeks of the recent election, and this mailer fails to provide accurate, legally required information about who paid for this electioneering communication. Please note, this mailer (a copy of which is attached to this complaint) is **in addition** to the 9 mailers I submitted as examples paid for by the PAC this non-profit foundation supported to also campaign in support of the large \$345 million bond tax campaign. It is highly likely there are additional mailers and media campaign this foundation financed in addition to the PAC media campaign which have gone entirely unreported to the PDC.

### **3). Failure to report expenditures (Violation of RCW 42.17A.240, RCW 42.17A.235)**

As evidenced by the attached mailer, there are obvious campaign expenditures which this non-profit foundation has failed to report to the PDC. Please note, the mailer attached as an example is just one I could find. There are likely to be more mailers and additional political expenditures by this non-profit entity which have also gone unreported. It is likely this information can only be uncovered with a thorough audit of this foundations expenditures during the last year leading up to and during this political campaign.

As detailed in my most recent complaint against this foundation, It should be noted that this non-profit donated a massive amount of funding to support a ballot proposition (\$735,000). This was not a small organization or group of ignorant activists. They had ample funding to hire competent campaign staff, compliance staff, and already pay legal teams to manage their operations.

However, in addition to the \$735,000 this Foundation contributed to the Approve Prop 1 - EvergreenHealth Sponsored by EvergreenHealth Foundation PAC, they also donated \$100,000 to another PAC (**see attached C3 reports filed by Approve Prop 1 – Our Public Hospital PAC – see PDC Report # 100897234 and Monroe Yes PAC – see PDC Report # 100884573**). Although these two C3 reports are confusingly filed under different names, both documents can be found under the "Approve Prop 1 – Our Public Hospital PAC" filings.

Please keep in mind, this is also in addition to the illegal, unreported mailer this Foundation sent out which was detailed in the earlier complaint.


