Complaint Description
<p><u>Sandra Robson</u> reported via the portal Wed, 18 Sept 2019 at 2:20PM</p> <p>To Whom It May Concern: I have reason to believe that the Whatcom County Affordable Housing Council political committee which is affiliated with the Building Industry Association of Whatcom County (BIAWC) may be in violation of WAC 390-16-011A. According to WAC 390-16-011A, if a political committee received eighty percent or more of its contributions from a person or from the person's members, officers, employees, or shareholders under RCW 42.17A.005(46), it shall include on its C-1pc the name of at least one sponsor in the committee's name.</p> <p>RCW 42.17A.005(46) defines "Sponsor" as: "(46)(a) 'Sponsor' for purposes of an electioneering communications, independent expenditures, or political advertising means the person paying for the electioneering communication, independent expenditure, or political advertising. If a person acts as an agent for another or is reimbursed by another for the payment, the original source of the payment is the sponsor. (b) 'Sponsor,' for purposes of a political or incidental committee, means any person, except an authorized committee, to whom any of the following applies: (i) The committee receives eighty percent or more of its contributions either from the person or from the person's members, officers, employees, or shareholders; (ii) The person collects contributions for the committee by use of payroll deductions or dues from its members, officers, or employees."</p> <p>The definition of "Person" as defined in RCW 42.17A.005(38) causes me to believe that the BIAWC organization would fall under that definition of "person." The pertinent section in RCW 42.17A.005(38) reads: "(38) 'Person' includes an individual, partnership, joint venture, public or private corporation, association, federal, state, or local governmental entity or agency however constituted, candidate, committee, political committee, political party, executive committee thereof, or any other organization or group of persons, however organized."</p> <p>As of today's date, September 18, 2019, the PDC's website shows that the Whatcom County Affordable Housing Council political committee has received \$5,149.00 in cash contributions, and has received \$160.00 in In-kind contributions. Out of that total of \$5,309.00 in contributions received, only \$350.00 of that total comes from persons which are not listed as members and/or officers (leadership) of the BIAWC, according to its online Member Directory which is on the BIAWC's website and can be searched by member name. I have attached a screenshot photo of the 2019 BIAWC Leadership list. [results/?txtDirSearch=Roger%20alms](#) After looking through (to my best ability) all of the listed 92 contributors to the Whatcom County Affordable Housing Council political committee as shown on the C-3 forms on the PDC website, only these 5 persons' names are not listed as members and/or officers (leadership) of the BIAWC according to its online Member Directory and its 2019 Leadership list on the BIAWC's website: CCC Services contributed \$50 Charlie Crabtree contributed \$100 Bryan Jones contributed \$100 Inspired Closets contributed \$50 RCI Construction contributed \$50 The rest of the contributors (87 in number) to the Whatcom County Affordable Housing Council political committee are listed as members and/or officers (leadership) of the BIAWC according to its online Member Directory and its 2019 Leadership list on the BIAWC's website. Because the Whatcom County Affordable Housing Council political committee appears to have received eighty percent or more of its contributions from a person or from the person's members, officers, employees, or shareholders under RCW 42.17A.005(46), it causes me to believe that the Whatcom County Affordable Housing Council political committee should include on its C-1pc form the name of the Building Industry Association of Whatcom County (BIAWC) in the committee's name, according to the intent of WAC 390-16-011A. I request that the PDC address this matter I've brought to its agency's attention as soon as possible because the November 5, 2019 general election season is already underway, yet the public and voters have not had this specific and important information about the Whatcom County Affordable Housing Council political committee made transparent and available to them.
