Public Disclosure Commission Statement of Understanding

Darold Brandenburg: PDC Case 58161

I Darold E. Brandenburg, hereby acknowledge that I, as a 2019 Candidate
(Printed Name of Respondent) seeking the office of Fire Commissioner in Okanogan Fire
Protection District 6:

- Exceeded the \$5,000 contribution limitations of the Mini Reporting Option on July 27, 2019, in violation of WAC 390-16-125, when I made a \$988 personal in-kind contribution to my Campaign for a "Credit card purchase" for goods and services, bringing my total contributions to \$5,227.
- Failed to timely file an amended Candidate Registration (C-1 report) for my 2019 campaign for election to the office of Fire Commissioner in Okanogan Fire Protection District 6, changing my filing status as a candidate under the Mini Reporting Option to the Full Reporting Option.
- Failed to timely file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports) for my 2019 campaign for Fire Commissioner in Okanogan Fire Protection District 6, as required for a candidate required to disclose contribution and expenditure activities under the Full Reporting Option.

I would like to avoid the time and expense resulting from a Brief Adjudicative Proceeding being scheduled by Public Disclosure Commission (PDC) staff.

Therefore, in lieu of PDC staff scheduling a Hearing, I am completing this Statement of Understanding, and enclosing a check or money order in the amount of \$150 as a penalty payment to resolve this matter as a candidate for public office in 2019.

The \$150 penalty being assessed is in accordance with the Penalty Schedule adopted by the Commission for Brief Enforcement Hearings set forth in WAC 390-37-143, for one violation of WAC 390-16-125.

The violation of WAC 390-16-125 was for exceeding the limitations of the Mini Reporting Option by receiving contributions in excess of \$5,000 prior to seeking authorization and obtaining approval from the PDC to change to the Full Reporting Option.

I understand that by completing this Statement of Understanding, I am acknowledging the violations of Chapter 42.17A RCW and Title 390 WAC set forth above, and I am waiving my right to a hearing in this matter. I further understand that this will resolve the issue of my exceeding the Mini Reporting option for the 2019 election cycle.
