We are in receipt of your latest email concerning another complaint filed by Mr. Glen Morgan, Case #58969, alleging failure to timely and accurately report debts and obligations.

I am attaching a PDF copy of the <u>envelope</u> from Emerald Outdoor Advertising dated 15 October 2019 along with copies of the two invoices which are dated 10/7/2019 and a copy of the check written on 10/17/2019 to satisfy the obligation. I also entered the expenditure into ORCA on 10/17/2019. The expenditure will appear on the next C-4 due October 29, 2019.

There was no hidden intent of not disclosing the expenditure. I have no idea as to why Emerald did not mail the two (2) invoices on the same day they were apparently printed. Perhaps accounting had to verify the billboards were actually done before mailing out invoices. But the fact is that the invoices were not processed by the U.S. Post Office until October 15, 2019 and we were not in receipt of the envelope/invoices until October 17, 2019, two (2) days after the October 15, 2019 C-4 filing date.

Mr. Morgan, who lives in Thurston County and is well known to the Washington PDC as a prolific filer of complaints, has taken a curious interest in a city council race hundreds of miles from his home. It was recently brought to our attention that one of the candidates involved in the race has allegedly been communicating with Mr. Morgan. We find that not only interesting but highly suspect. Perhaps the PDC should ask of Mr. Morgan as to his source of information concerning Ms. Peetz.

We respectfully request that the Washington Public Disclosure Commission take quick action on this complaint. It is our contention that the complaint filed by Mr. Morgan should be dismissed as unfounded and certainly it is frivolous.
