Primary concern and request for investigation: Spokane mayoral candidate Nadine Woodward has withheld significant financial information regarding her private business from the Public Disclosure Commission (required F-1 form) and has buried and confused her business details in a manner that makes it difficult to uncover those details and “follow the money”.

Screenshots referenced by ^(x) follow in order after the outline.

1) Ms Woodward failed to disclose on her F-1 filed with the PDC (100899140) for the period of 4/14/2018 through 4/14/2019 any income she or her spouse (Bruce Felt) receive from their private, for-profit, video-production business.

a. This F-1 ⁽¹⁾ dated as received 4/15/2019 is the only such form she filed with the PDC. This information was verified by an email received from the PDC on 10/21/2019: *“The F-1 Personal Financial Affairs Statement you received is the most recent F-1 filing for Nadine Woodward. She has not filed any F1 amendments, supplements, short form, modification/exemption since her filing submitted on 04-15-2019.”* ⁽²⁾

b. Ms Woodward has declared publicly on multiple occasions that she owns a downtown business. ^(3, 4)

2) Ms. Woodward is an executive for her private, for-profit, video-production business. She uses two titles for her position (Vice President and Governor), and two surnames (Woodward and Woodward-Felt).

a. Ms Woodward is captured on video speaking publicly at a 10/17/2019 Rotary Club forum, saying that she owns a downtown business, which she notes has been around for six years, and is across the street from the downtown Spokane venue where she is speaking. ⁽³⁾

b. In a 10/17/2019 Spokesman Review article, Ms Woodward is noted as Vice President of the company, called **Memories By Design**, in her interview with Spokesman Review reporter Adam Shanks for an article “Spokane’s Next Mayor” published 10/18/2019. From the article: *“She left the industry earlier this year and is vice president of Memories by Design, a video production business in Spokane.”* ⁽⁴⁾

c. Ms Woodward is noted in the WA State Secretary of State Corporations ⁽⁵⁾ and Department of Revenue ⁽⁶⁾ directories as a “governor” of the for-profit corporation **MBD Creations, Inc.**

d. In the WA State SOS and Dept of Revenue databases, her surname appears as Woodward-Felt but on the F1 that she filed with the PDC, her surname appears as just Woodward. ^(1, 5, 6)

3) Ms Woodward is using three different business names for her private, for-profit, video-production business, describing varying annual revenue (approximately \$40,000 to over \$1,000,000) and staffing levels (from 1-2 to 17 with 10 full time positions).

a. Memories By Design.

i. The **Memories by Design** website ⁽⁷⁾ shows Ms Woodward's husband Bruce Felt as President of the company and nine other staffers, but doesn't mention her name as a staff member or Vice President as she has mentioned her title and position in the company in multiple interviews and articles.

ii. See 10/17/2019 Spokesman Review article ⁽⁴⁾ where Ms Woodward is noted as Vice President of the company, called **Memories By Design**, in her interview with Spokesman Review reporter Adam Shanks for an article "Spokane's Next Mayor" published 10/18/2019. From the article: *"She left the industry earlier this year and is vice president of Memories by Design, a video production business in Spokane."*

iii. See Journal of Business 2014 article ⁽⁸⁾ noting when she and her husband purchased the **Memories by Design** business with 17 employees (including 10 full time) and producing 700+ videos per month, nationwide. At a minimum of \$125 per video (according to current website) this works out to be at least \$87,500 per month or \$1,050,000 annually. ⁽⁹⁾

iv. See April 2014 Funeral Business Advisor article ⁽¹⁰⁾ noting the new owners of **Memories by Design** (Felt and Woodward-Felt) and that the business had produced over 130,000 tribute videos over the past twelve years, from 2002-2014.

v. A 7/3/2019 article ⁽¹¹⁾ in the Inlander notes that *"Woodward has a personal stake in the issue: Her family's business, **Memories By Design**, is located in the building above the Baby Bar on First Avenue — closer to the STA Plaza than the Intermodal Center."*

vi. Alignable website shows Bruce Felt as small business owner of **Memories By Design**. ⁽¹²⁾

vii. This business name **Memories By Design** is noted as "inactive" or "administratively dissolved" on the WA SOS website ⁽¹³⁾ even though Woodward and spouse are clearly still using it as a business name in communication for her political campaign and on the official business website. ⁽¹⁴⁾

b. MBD Creations, Inc.

i. This is the business name registered for trade under the WA State Corporations and WA State Dept of Revenue. ^(5, 6)

ii. Ms Woodward is noted in the WA State Secretary of State Corporations ⁽⁵⁾ and Department of Revenue ⁽⁶⁾ directories as a "governor" of the for-profit corporation

iii. Registered in 2013 and 2014 respectively, and trademarked as **MBD Creations Inc.** ^(5, 6)

iv. The type of business is coded as *Motion Picture and Video Production*. ⁽¹⁵⁾

v. Her surname on these documents is Woodward-Felt instead of Woodward. ^(5, 6)

vi. The address listed on these WA state docs is 827 W 1st Ave. #301, Spokane 99201. This is the same address as **Memories By Design** according to the business website. ^(5, 6, 7)

vii. **MBD Creations** also appears on various business sites such as Manta, Cortera, and others. ⁽¹⁶⁻¹⁹⁾

viii. It appears at both the 827 W 1st and 4718 S Napa address. ⁽¹⁶⁻¹⁸⁾

c. Spokane Video Legacy.

i. This is the business name that appears on multiple sites including Google Maps and Yelp. ^(20, 21)

ii. The address listed is the 4718 S Napa address. This address matches Ms Woodward's home address on the F-1 she submitted ^(20, 21)

iii. Ms Woodward's husband Bruce Felt is noted in the Manta Business website ⁽²²⁾ as the manager of the video production business **Spokane Video Legacy**. This listing has staff of 1-4 and annual revenue of less than \$500,000

iv. A second Manta listing ⁽²³⁾ for **Spokane Video Legacy** shows staff of 2 and annual revenue \$48,013

4) Ms Woodward is using two different business addresses for her private, for-profit, video-production business.

a. The address 827 W 1st Ave Suite 301 appears:

i. On the Memories By Design website ⁽⁷⁾

ii. For MBD Creations Inc in the WA SOS and Dept of Revenue databases ^(5, 6)

iii. Her description of the Memories By Design business during the Rotary Club forum on 10/17/2019 ⁽³⁾

iv. On the OPENGOWA and Cortera business site for MBD Creations Inc ^(17, 18)

b. The address 4718 S Napa appears:

i. On Ms Woodward's F1 (financial disclosure form) submitted to the PDC ⁽¹⁾

ii. As the address of Spokane Video Legacy on Manta, Yelp, Facebook, Mapquest and more ⁽²⁰⁻²³⁾

iii. On a Manta site for MBD Creations Inc ⁽¹⁶⁾

Secondary concern and request for investigation: Is it a violation to pay a dependent/child living at home for campaign reimbursement? Is daughter Nicole living at home as indicated on the F1 or is that falsified because Nicole is living in Seattle?

1) Spokane mayoral candidate Nadine Woodward has indicated on her F1 ⁽¹⁾ that her 22-year old daughter Nicole Felt is a dependent at her 4718 S Napa address.

2) However, on her campaign website ⁽²⁴⁾, Ms Woodward calls her daughter "Coley" and indicates she is a graduate from University of Washington and living in Seattle. So is her daughter a dependent and living at home or not?

3) Also, on at least one C4 ⁽²⁵⁾ Ms Woodward's campaign is paying Nicole Felt directly, at Ms Woodward's 4718 S Napa address.

What impact does the alleged violation(s) have on the public?

Further erosion of the public's faith and confidence in our government. Public's inability to make informed decisions about future leaders during the election. Corruption and deceit in government.

- (1) The 4/15/2019 F-1 that Ms Woodward submitted to the PDC showing only her "D" income (\$48,000 to \$119,999) from broadcasting for a local network. This form does not indicated any income from her family business for which she publicly claims to be the Vice President, and her husband President. This F-1 also lists her spouse Bruce Felt and dependent (daughter) Nicole Felt. According to the rules Part 1 of the F-1, all income in excess of \$2,400, including from spouse is to be listed.

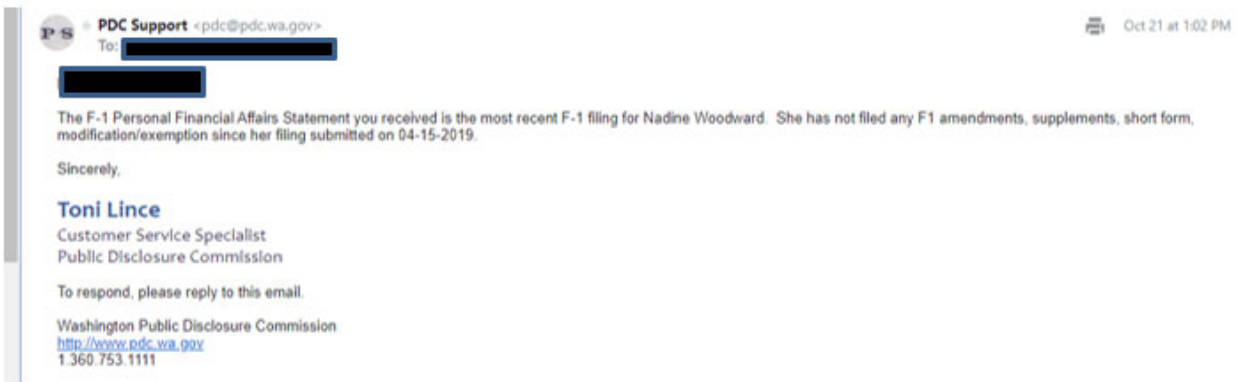

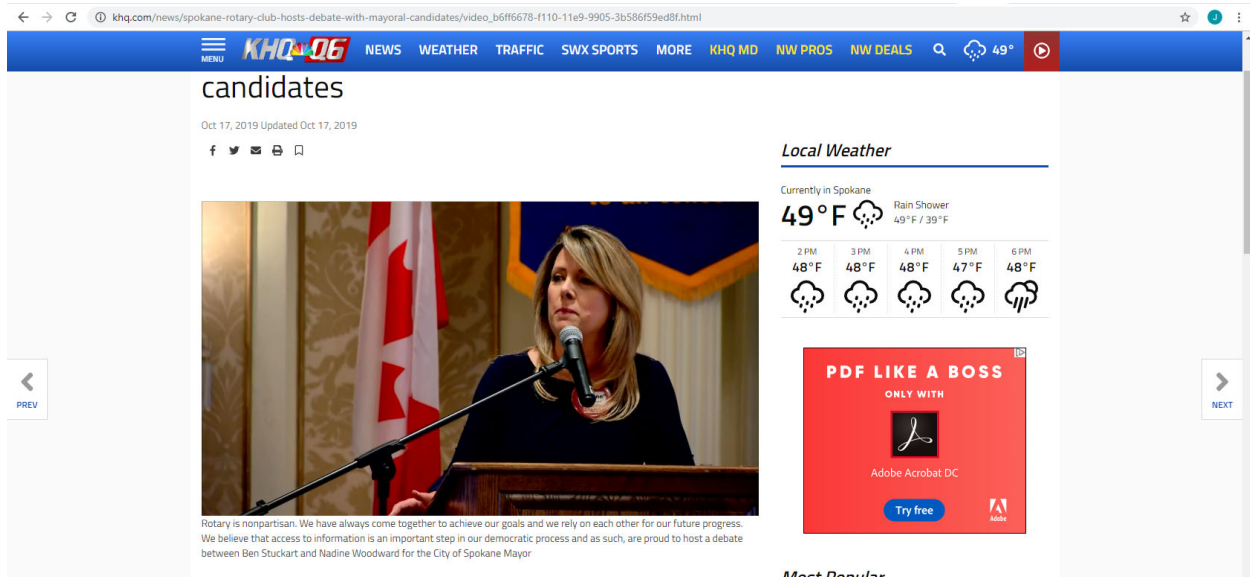



Memories By Design under new ownership

Bruce Felt and Nadine Woodward-Felt have bought Memories By Design, a business-to-business video production company for the funeral and cremation industry nationwide, formerly owned by Barbara Gustin, who founded the company in 2002.

The business, which specializes in custom tribute videos for families whose loved ones have died, blends photos, custom background scenery, and custom music into its videos.

The business occupies about 3,500 square feet in the Courtyard Office Center, at 827 W. First, and employs 17 people, 10 of whom are full time.

The company currently produces about 700, six- to nine-minute videos per month, for funeral homes throughout the U.S., as well as custom videos of up to 30 minutes in length. Felt says the videos, which are used during funeral services, help people celebrate a person's life and preserve memories honoring that person.

"The strength of the company lies in its unique ability to produce outstanding handcrafted custom videos using a trained, skilled and, most importantly, a compassionate staff," he says. "This allows funeral homes to focus on their specific responsibilities and services, while the families can address their personal matters."

Both Felt and Woodward-Felt are veterans of broadcast journalism, Felt in video production and Woodward-Felt as a news anchor for KXLY-TV, Spokane's ABC affiliate. Nadine will continue to anchor newscasts for KXLY and will be involved in Memories by Design as much as possible, while Bruce will oversee day-to-day operations.

Changes already under way include several customer-focused improvements including technical software upgrades and new theme packages as well as a website redesign with more user-friendly navigation, information, and tools, Felt says.

Born and raised in Washington State, Nadine Woodward is an award-winning broadcast journalist, mother, business owner and proud Spokaneite. During a 28-year career on Spokane television, she shared with us the highs and lows of tumultuous decades.

After broadcast news jobs in Idaho, Nadine arrived in Spokane in 1990, first working at KREM, then moving to KXLY in 2010.

She has reported on the city - from the change in city government to a "strong mayor" system, the revitalization of downtown, and the challenges of growth and development on the North Side and in other neighborhoods. From severe snow, wind and fire storms, to the tragic Freeman school shooting and our homeless crisis - she has seen firsthand how people came together in times of adversity.

During her television career, Nadine made the Spokane community the focus of her work, both on and off camera. She supported, emceed events, fundraised and served as honorary chair for a multitude of causes, including Spokane County Alzheimer's Association, Susan G. Komen Race for the Cure, Go Red for Women/American Heart Association, Anna Ogden Hall, Teen Challenge, Rescue 4 All/Inland Northwest Animal Rescue, Women Helping Women, March of Dimes, Red Cross Heroes, Children's Miracle Network, Sacred Heart Children's Hospital, and Coats 4 Kids.

She got her first job in television while still a student:
"Vancouver's cable company embarked on a pioneering idea to create a local newscast anchored by members of the community. I auditioned, and out of hundreds of hopefuls, got the female news anchor position. After attending college classes during the day, I would then anchor the evening news during my junior and senior years. The pay? \$5 a newscast. But the experience was priceless."

Growing up in Vancouver, her parents instilled a strong work ethic. As a teenager, she spent summers picking strawberries, cucumbers and zucchini.

Nadine worked her way through college, graduating from the University of Portland in 1985 with a Bachelor of Science Degree. At Clark College and UP she was very active, serving on student government, was an editor on the student newspaper, an award-winning member of the debate team, and did video production work.

Nadine received many awards for her broadcasting work, but is proudest of the Silver Circle Award from the National Academy of Television Arts and Sciences. It is one of the highest honors given by NATAS recognizing television professionals who have "made an enduring contribution to the vitality of the television industry, set standards of achievement, and given back to their communities."
