Dear Ken Lee:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed October 22, 2019. The complaint alleged Nadine Woodward, a 2019 Candidate for City of Spokane Mayor, may have violated RCW 42.17A.710 by failing to accurately and completely disclose personal financial information on a Personal Financial Affairs Statement (F-1) report.

PDC staff reviewed the allegations; the applicable statutes, rules, reporting requirements, applicable PDC reports and the response provided by Nadine Woodward, to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- Nadine Woodward filed an F-1 and two F-1 supplements on April 15, 2019.
- Woodward only reported income from April 2018 to April 2019 from Spokane Television, Inc.
- In a supplemental F-1, Woodward reported owning 50 percent of MBD Creations, Inc., and Woodward's spouse owning 50 percent of MBD Creations, Inc.
- Woodward stated, "Bruce and I received no income from our business, Memories by Design, in 2018. Money generated by the business that year was earmarked to pay off a business loan."
- Woodward also noted Nicole Felt "graduated from the University of Washington in Seattle in June 2019 and moved back home in Spokane in August."

Based on these findings staff has determined, in this instance, the alleged violation of failing to accurately and completely disclose personal financial information on a Personal Financial Affairs Statement (F-1) report does not amount to a violation warranting further investigation.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
