To whom it may concern,

It has come to my attention that serious violations of Washington State's campaign finance laws (**RCW 42.17A**) have been committed by Fuse Votes PAC during the 2016 general election political campaign season.

#### **1)Accepting illegal over limit contributions within 21 days of an election (Violation of RCW 42.17A.420(1))**

It is illegal for a PAC to accept contributions of over \$5,000 from any one source within 21 days of an election. Yet, this PAC did exactly this when it accepted \$8,000 from the SEIU 925 Local Services PAC on November 8, 2016 on election day (see attached C3 for source):

This PAC should be fined by the PDC for violating the campaign finance laws so egregiously when they had plenty of money to ensure they remained compliant with the law.
