To whom it may concern,

It has come to my attention that Megan Dunn, a candidate for the Snohomish County Council has violated the Washington State Campaign Finance laws (**RCW 42.17A**). The details of these violations are as follows:

1) Attempt to conceal campaign donations (Violation of RCW 42.17A.235, .240)

It appears that this campaign has concealed a \$500 donation from the UFCW 21 PAC (See C-4 report PDC Tracking# 100938503 from UFCW 21 PAC). I have also attached this for reference. This PAC reports they donated \$500 on 10/7/2019 to the Megan Dunn political campaign. However, this candidate has refused to report this PAC cash on any of the C3s filed since that date. It should be noted for the record that the UFCW 21 PAC issued many donations on the same day and it appears that nearly all the other candidates and special interest PACs who received this cash have already reported it. This political campaign, however, chose to conceal this information from the public. If it can be determined that this was done willfully, then this candidate could be charged under RCW 42.17A.750(2)(a).

2) Failure to provide adequate details for certain advertising expenditures (Violation of RCW 42.17A.235, .240, WAC 390-16-037).

On at least two occasions, this campaign has also failed to provide adequate details on signs purchased from "Capital Press." See **PDC Tracking # 100938176** on 9/27/19 for \$1,317.60 and **PDC Tracking # 100909743** on 4/23/19 for \$1,372.50. This campaign should be required to correct these illegal reports and correctly report this information to the PDC and for the public.

The PDC should investigate to see if this political campaign, run by experienced and professional consultants and treasurers is violating additional elements of the state's campaign finance laws.
