

## Complaint Description

Dear Public Disclosure Commission,

I write today to submit a complaint against the campaign committee of Rebeca Muñiz, candidate for Director of the Seattle School Board, Pos. 3. While actively pursuing a campaign for Seattle School Board, Ms. Muñiz has chronically failed to report campaign contributions and expenditures as required by law. Even after public admonishment in the *Seattle Times*, Ms. Muñiz remains non-compliant, still having failed to report any campaign activity since the August primary.

Ms. Muñiz has consistently failed to timely report her monetary contributions (C-3 reports) and expenditures/summary (C-4 reports) as required by law. Between May 11, 2019, and October 20, 2019, Ms. Muñiz failed to submit any of her financial disclosure reports. In doing so, Ms. Muñiz has chronically violated RCW 42.17A.235.

Ms. Muñiz has been aware of her non-compliance from before September 24, 2019, when she interviewed with the *Seattle Times* editorial board, informing them that the PDC reporting problem was due to a “software problem her staff [were] working to resolve”. This was over five months after Ms. Muñiz’s last report submission, and no correction was made for nearly a month, until October 21. Although Ms. Muñiz submitted C3 and C4 reports through August 6, as of this submission, Ms. Muñiz is still in active non-compliance for all subsequent reports.

Ms. Muñiz’s non-compliance to RCW 42.17A.235 has been chronic, pervasive, and knowing. As a Seattle Public Schools district resident and voter, I appreciate the PDC’s timely attention to this matter.
