**Re: Google LLC's Response to Complaint of Tallman Trask, PDC Case No. 59475**

Dear Mx. Blackhorn:

I write in response to your October 30, 2019 letter regarding Mr. Tallman Trask's October 30, 2019 complaint alleging that Google violated RCW 42.17A.345 and WAC 390-18-050 by failing to provide certain advertising records within 24 hours of his initial request. Thank you for bringing this matter to our attention. We provided information in response to Mr. Trask, and enclose that communication herewith.

Although we have provided Mr. Trask with the information, his complaint should be dismissed. Mr. Trask's complaint to the PDC is improper because Mr. Trask had not communicated his request to Google at a place of business during normal business hours or through another electronic means designated by Google.<sup>1</sup> Instead, Mr. Trask sent his request to Google by submitting it via an online portal on a Google Ads Help Center page that is designed for Google Ads account holders to submit concerns and/or ask for assistance with their Google Ads advertising accounts. It was not, and does not purport to be, a place where users can submit these requests for information relating to Washington state and local election ads, and this should have


been obvious to Mr. Trask. Because Mr. Trask did not contact Google in a method intended for the processing of these requests, we believe that his complaint to the PDC is premature as Google had not effectively received his request by the time his complaint was filed.

As you are aware, Google has discontinued accepting these types of ads in Washington State while we continue to work with the PDC, and we have instituted several safeguards to prevent these ads from appearing on our services. Because these advertisers repeatedly circumvented our systems in order to violate our policies, the accounts associated with this activity have now been suspended.

Google shares the Public Disclosure Commission's goal of bringing transparency to election advertising. Given that Mr. Trask has received the information requested, notwithstanding the issues we discussed above relating to how he submitted his request, we respectfully request the PDC dismiss this complaint.

We recently received notice of your request for information related to Google advertising purchases disclosed in the Public Disclosure Commission (PDC) reports numbered 100930145 and 100939902. Google does not accept ads related to ballot measures and candidates for state and local elections in Washington, and advertisers that display these ads are not only violating our [policies](#) but also circumventing the systems Google has in place to prevent this abuse.

We understand that you submitted your request via a Help Center page designed for Google advertisers to seek assistance with their accounts. Google does not accept requests for this type of information through this Help Center page, which is dedicated to Google Ads advertisers. Requests of this nature should be sent to: [wa-election-ads@google.com](mailto:wa-election-ads@google.com).

Although we did not see specific information about the ads in question in your request, we undertook an investigation based on the PDC reports that you cited. We have identified the following information that we believe is responsive to your request:
