To whom it may concern,

It has come to my attention that, once again, as is customary for this well-financed and experienced political consultant, the SeaTac Progress PAC (no longer officially "sponsored" by John Wyble, but run by him nonetheless) has violated and continues to violate Washington State's campaign finance laws (**RCW 42.17A**) during the current political election cycle.

Please note, these are in addition to the previous violations committed by this PAC as outlined in PDC enforcement case # 58914, and they are unique violations separate and on top of the violations outlined in PDC enforcement case #59312

1) Concealment of the top 5 donors on political mailer (Violation of RCW 42.17A.320, .350)

The attached mailer produced by this PAC is being received by voters today. It shows the following persons as the "Top 5 Contributors"

John Wyble

SEIU WA State Council PAC

Lucinda Grande (not her real name)

Jeremy Lauzao

Christoph Folger (not his real name)

Top 3 Donors to PAC Contributors: SEIU Quality Care Committee, Public School Employees of WA Political Fund, SEIU Healthcare 1199NW PAC.

These same people were listed on this PAC's C3 (See PDC Report # 100940031) as donating on these dates:

However, the following people actually donated more than at least one of the listed "top 5 donors" before this mailer was sent, and this fact was reported by the PAC on their C3s, so John Wyble is clearly and habitually attempting to conceal the real top 5 donors and willfully breaking the law with malice aforethought, which appears to be a normal for him in his business. Even if he is not obligated to report donations below a certain threshold, but then chooses to falsify those donors he does list to pretend they are in the top 5, when they clearly are not – this is a violation:

While Mr. Wyble is not obligated to identify "top 5 donors" whose contributions don't meet the legal thresholds required and defined in RCW 42.17A.350 (and more clearly defined in RCW 42.17A.005(29)(a)(iv)), he completely failed to report the true top 5 donors (which is actually illegal and one of the many areas where he habitually appears to break and mock the law). This was not an accident, this is an experienced political consultant and treasurer with years of experience who has made substantial sums of money doing this for a living. He knows the law, and he is mocking it here with the expectation (not unreasonable) nothing will happen to him. His historic experience failing to comply with the law with no consequences has convinced him that breaking the law is no big deal. The primary purpose behind falsifying the top 5 donor statement appears that he can't find enough local residents of SeaTac willing to support his PAC. There is nothing illegal about recruiting and using donations from outside the local community of course – this PAC wouldn't exist if this were the case – however, that is not a license to falsify the statement of who those top 5 donors actually were. He should be proud of their help and not attempt to conceal their true identities from the public.

This is a pattern of concealing the Top 5 donors from the PDC and the voters, and unfortunately it doesn't end with just falsifying the list.

Additionally, before it is forgotten, as mentioned in a previous complaint (See PC Enforcement Case #59312), the Teamsters Legislative League PAC contribution (see **PDC report # 100938006 – See attached**) also reported and made to this PAC on 10/11/2019, would also have been required to be listed in the top 5 donors, but has been willfully concealed by this PAC from the public as well, and this concealment continues at this time, despite the previous complaint bringing this concealment to the attention of the PDC and serial campaign finance violator John Wyble.

2) Willfully falsifying names of top 5 donors to obscure their true identities (Violation of RCW 42.17A.240, .235)

It appears that on the list of the Top 5 contributors to this PAC, the name of one of the supposed top 5 donors (who is actually the 9th or 10th highest donor depending on how many other donations have been concealed from the public by this secretive, dark money PAC), is "Christoph Foulger", however this PAC falsely claims this donor as "Christoph Folger" which is not true, and falsely represents the real donor to this PAC.

However, that is not the only one. "Lucinda Grande" is actually "Cindy Grande" and is registered to vote under the name "Cindy" not "Lucinda." This appears to be another effort to misdirect the public and conceal who these donors really are (see attached voter record information obtained from the Secretary of State database to confirm)

3) Failure to properly list the top 3 donors to the PACs who funded the PACs listed in the top 5 donors (RCW 42.17A.350)

Now, this is where we get into another violation, but one a little more subtle than the violations usually committed as a matter of course by John Wyble. This is still a new statute (and I was on the record opposing it, but I didn't write the law), and compliance has generally been ignored by the PDC so far. However, this is the election cycle where the law needs to be hashed out as to what it means.

A partial attempt by this PAC to partly identify the top three donors to the PAC in the top five was made. However, based on the way this statute was written and understood by the legislators who passed the law, when those top 3 donors are PACs, the entity who puts out the campaign material is obligated to further drill down and identify THOSE top three donors to those PACs as well until they come to the final Russian nesting doll style person (or corporate entity) behind the cash.

All three identified PACs needed to have further information detailed about THEIR top 3 donors as well. See attached screen shots from today's PDC contribution screens for these three PACS – this information was concealed by this PAC and as a sophisticated PAC with a very experienced (even if not much experience following the law) paid professional consultant in charge, he, of all people should know how to comply.

Finally, based on my most recent complaint against Representative Mia Gregerson and the missing \$10,000 from her surplus account and the likelihood this was concealed and laundered to John Wyble with the intention of starting this weird little PAC, I might have to revise the analysis of previous complaints and the effort to unravel and explain exactly who the top 5 donors (and earlier sponsorship) of this PAC really is. Of course, if that investigation exposes this transfer (and I can only see unraveling this mess by subpoenas of banking records from the colluding parties including John Wyble), then previous complaints may need to be revised to include the myriad of additional violations that seem to be continuously uncovered in any casual investigation of this operation.

Please let me know if you want more details on this one. It seems likely this crew will continue to break the law until they are forced to start complying with the law, so I'm sure this isn't the last complaint.


