<p><u>Glen Morgan</u> reported via the portal Mon, 28 Oct 2019 at 1:09PM</p> <p>To whom it may concern,</p> <p>It appears that NARAL Pro Choice Washington PAC has committed various violations of Washington State’s campaign finance laws (RCW 42.17A). These violations appear to be systematic, willful, and committed with malice aforethought. Please keep in mind, this PAC has been reminded by the PDC to follow the law when I caught them committing other violations in the past (PDC Enforcement Case # 34202)</p> <p>1) Concealment of campaign contributions to political candidates (Violation of RCW 42.17A.235, .240)</p> <p>It appears that this PAC has made political contributions to a variety of political candidates throughout Washington State, and then concealed this fact from the public. I will specifically identify the following contributions which have been reported by candidates but which this PAC has concealed from the public:</p> <p>2019:</p> <ul style="list-style-type: none"> · Contribution of \$100 to April Barker, Bellingham Mayor candidate – 9-30-19 (unreported by this PAC (See PDC Report # 100934766)) · Contribution of \$100 to Megan Dunn, Snohomish County Council candidate – 9-30-19 (unreported by this PAC (See PDC Report # 100935214)) · Contribution of \$400 to Satpal Sidhu, Whatcom County Executive candidate – 9-26-19 (unreported by this PAC (See PDC Report # 100934025)) · Contribution of \$400 to Ben Stuckart, Spokane County Mayor candidate – 9-25-19 (unreported by this PAC (See PDC Report # 100933350)) · Contribution of \$100 to Karen Stratton, Spokane County council candidate – 9-21-19 (unreported by this PAC (See PDC Report # 100933203)) <p>There are likely more examples of this, but from a practical standpoint, this PAC hasn’t filed a C4 since June 17th (other than amendments to historic C4s from earlier in the year – for example the C4 – PDC Tracking # 100939709 was filed on October 21, 2019 to fix the C4 PDC Tracking #10091189 which was filed on June 17, 2019). No record of any contributions has been made since June, and yet all the above transactions should have been reported to the PDC.</p> <p>It appears almost certain that additional contributions have been hidden from the public, and, once again, I want to point out to PDC staff, that this active concealment of contributions is</p>

being made in the critical 21 day window of an election when ballots having been distributed to the public and this information is still concealed from the public by this well-funded, long-time PAC. Even with professional experienced staff and even after the PDC has warned them to follow the law when I exposed their historic violations, they decided to violate the statute again.

It appears likely that they will continue to do more in the future unless some intervention by the PDC is made to ensure they actually follow the law and understand that they are not above the rules which have been long established and codified in **RCW 42.17A**. It has NEVER been legal to conceal your contributions to candidates by PACs like this. It seems possible and even likely that this PAC chose to commit these violations and may be subject to criminal sanctions as defined in **RCW 42.17A.750 (2)(a)**.
