Subject: Complaint regarding One Washington Equality Campaign, PDC Case 59780

Dear Craig Keller:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed November 4, 2019. The complaint alleged One Washington Equality Campaign violated RCW 42.17A.320 for failing to provide complete and accurate sponsor identification in political advertising, specifically a pre-recorded call/robocall.

To determine whether the record supports a finding of one or more violations, PDC staff reviewed the attachments you provided and the response from Toussaint L. Myricks, legal counsel for One Washington Equality Campaign (OWEC).

We found the following:

- In response to the complaint Myricks stated “At no time, were pre-recorded calls ever funded, created, distributed or used by or on behalf of OWEC for political advertising purposes.”
- Based on Approve I-1000 sponsorship information, PDC staff initially sent the complaint to the incorrect Committee.
- The complaint has now been sent to the Washington Fairness Coalition and is being investigated under case number 60458.

Based on this information, the PDC finds that no further action is warranted and has dismissed PDC Case 59780 in accordance with RCW 42.17A.755(1).
