

Thank you for your email. Here is the information you requested:

- 1) Yes, I still have the physical flyer. I have attached photos front and back.
- 2) I did not receive a response to that email, or any additional communication or response from Doug Speas or the yes campaign email address (which Doug controls). However, after one of our neighbors called out Kerry Ticknor personally and publicly on Nextdoor.com (for withholding the information), she private messaged me and asked what information I was requesting. After a couple message exchanges she furnished the requested information. This was on 11/16/19, well after the election had passed. The date is consistent with her voicemail message stating they would not release the information until after the election, and is also consistent with Doug's public statement on Nextdoor.com to the same effect that they would not release any of the information until after the election.




