Dale Fonk - Chairman of the 45th LD GOP; and Toby Nixon - Secretary of the 45th LD GOP; have violated RCW 42.17A by mis-representing their contribution for mailers.

This states that contributions for mailers was "For Al Taylor" when the mailer does not include any reference to Al Taylor.

This is actually an "attack ad" ; or "Against" the other Candidate for Position #6 of Woodinville City Council. This was done against Nicolas Duchastel.

The C6 report also does not include the number of mailers sent.

The mailer falsely claims that Nicolas Duchastel was endorsed by Seattle Special Interest and was also endorsed by Seattle Councilor Sawant. This is inaccurate.

What impact does the alleged violation(s) have on the public?

Misinformation:

1. The public is led to believe that the GOP, Toby Nixon and Dale Fonk had a positive campaign when in reality they were doing "attack ads". They have every right to send these ads of bad taste, but, they should be up front about it and not mis-represent this;
2. The number of mailers sent is important information to be known by the public. It was not listed on the C6 report;
3. Nicolas Duchastel was not endorsed by "Seattle Special Interest" and was not endorsed by Seattle City Councilor Sawant;
