She has routinely been pas due date of almost all C4 Filing dates. She also failed to properly declare as a candidate upon her announcement within 15 days back on January 25th, 2019 as shown by her filings and a local article in the Yakima Herald Dated January.

What impact does the alleged violation(s) have on the public?

It has come to my attention that Liz Hallock, who ran for Yakima City Council position #5 this year has committed numerous violations of Washington State's campaign finance laws (RCW 42.17A). Hallock's campaign has regularly failed to follow Washington State's Campaign Finance laws as they apply to the reporting of expenditures. Many C4s this campaign has filed contains violations of the statute and the rules written by the Public Disclosure Commission which support the statute.

Failure to file timely C4 (Violation of RCW 42.17A.205, .210, .215). See also WAC 390-05-200

It appears that the Hallock's campaign was substantially late in filing the C4's for their campaign.

According to PDC Report #100944180 this campaign's first Expenditure of \$27.62 was received on

6/03/2019, and according to PDC Report #100944181 this first expenditure was \$1500.00 on 1/25/2019.
