Hi Tabatha, my apologies for not supplying all of the necessary information. My full mailing address is 13420 339th Ave SE, Sultan, WA, 98294.

This situation occurred during the last weeks of the election (Nov 5, 2019) following a School Board meeting (of Oct 28, 2019) in which I questioned a Special Ed. contract between our District and the Overlake Hospital, Bellvue, WA. In part, I asked if these students were educable, thinking that we were in the business of K-12 education. Apparently this caused a last minute write-in campaign (candidate info not available at this time) to un-seat me as a Board member. At issue here is the fact that Dan Chaplik, Sultan School District Superintendent, posted on the Schools Facebook page and/or other communication to the community, using school resources, that directly related to and/or influenced voters regarding my campaign for this position. In regard to when and where the comments were made I am not sure. The only notice of this activity by the Sultan School District Superintendent, Nov. 1.

Although I was not mentioned by name in the communication, Sultan, WA, is a small community and there was no doubt as to who the reference was aimed at. As the election results show, the number of voters electing the write in candidate was more than 10% greater against me than those of the other two open position in this race. I believe that this post contributed greatly to my opponent, the write-in candidate. My contention is that there was no other reason to initiate this communication to the community at this time, other that for political purposes. In addition, this communication was not approved by the Board of Directors. This certainly was not an activity which could be regarded as a regular conduct of the office of Superintendent.

BASIC PRINCIPLES

Public facilities may not be used to support or oppose a candidate or ballot proposition. <u>RCW</u> <u>42.17.555</u>. Facilities include school district equipment, buildings, supplies, employee work time, and district publications. The statute includes an exception to the prohibition for "activities which are part of the normal and regular conduct of the office or agency."

In summary, the facebook post was authored by Sultan School District Superintendent Dan Chaplik prior to the Nov 5, 2019 Election, certainly at some time between Oct 28, and Nov 1. I was unopposed for the position of School Director #4 until immediately following the Sultan School Board meeting of Oct. 28, 2019. I was not aware of Superintendent Dan Chaplik's public communication until Fri. Nov. 1, 2019. I am also unaware of any other activities that Superintendent Chaplik may have had in this election process. The write-in candidate was Heidi, not sure of the last name, the SnoCo Auditor seems to be busy with a re-count, I will get the information concerning Heidi to you as soon as the Auditor can get it to me.

Thank you very much for your time, I hope I have provided you with a better picture of these circumstances. I have also attached a letter that I read into the record at the next Board Meeting of Nov 12, 2019. Please do not hesitate to contact me for any additional information that you may need.

Well, it's been an interesting couple of weeks. The purpose of this summary is to relate the facts concerning the events that have taken place since our last Board

meeting.

Apparently, my question concerning agenda item 12 of the Board Packet of October 28, 2019, was taken out of context and the intent misunderstood. This has caused some in our community to become upset. This was a QUESTION not a STATEMENT. It was a question regarding the authorization of a contract between Sultan School District and Overlake Hospital & Medical Center in Bellevue. Actually, there are 2 contracts in question, one for each student, totaling \$216,000.00 (one for \$84,000.00 & one for \$132,000.00). Interestingly, these contracts were already signed on July1, 2019 by a Gayle Wilson (as the person authorized to "bind" said district to the foregoing agreement).

This raises several questions...

2). I was completely unaware of any issues concerning the Monday board meeting until King 5 news called at 10am Thursday, October 31. They were requesting an interview at 11am regarding my question. Also, at that time the reporter informed me of a write-in campaign to unseat me. I have no problem with running a contested race; however, to act in secret at the last minute is another matter, *and raises more questions*...

3). On Nov 1 at 1:51pm, Superintendent Dan Chaplik published and distributed a message to the Sultan Community, excluding myself. The message in part stated: *"the comments made by the director does not reflect the sultan school district's mission, vision, goals and guiding beliefs for and about our students"...* I received a copy from a neighbor at a later time. The content and manner in which this message was conveyed *raises even more questions...*

To be clear - I was elected by the constituents in this community to serve on the Sultan School Board and as such my decisions should reflect the community interests. One of the important jobs of a school board member is to oversee how your tax dollars / our tax dollars are being spent. The truth is; I dared to ask the hard question as to how your tax dollars were being spent between Overlake Hospital and the Sultan School District.

At no point did I ever make the STATEMEMT that <u>ALL</u> special needs children are un-educatable. Rather, my QUESTION was directed only to the 2 contracts and whether this expense was reasonable & appropriate. **I** simply asked a question...

As a current member of Sultan School Board, and a tax payer in this community for over 40 years, I or anyone else for that matter, should be able to ask financial questions freely without being bullied, targeted or shamed. After all, any and all School District expenditures are a matter of public interest and record.

In regard to these events and how they occurred, is greatly disturbing and certainly distracts from the purpose of our job. If I have the privilege of being re-elected to this honorable position, it is my hope that we, as a Board, can move forward working together to bring transparency and prudent spending to our community.

It is my earnest desire that we provide *ALL* children a safe and thriving learning environment. *I will continue to ask the hard questions*
