Per [RCW 42.17A.560](#), "No legislators, other state officials or their employees or agents may solicit or accept contributions for any state or local office candidate, to defray public office related expenses, or to retire a campaign debt during what is known as the "legislative session freeze period." The freeze period is in effect during the regular legislative session, the 30 days before the regular session and during any special session of the legislature."

The 2020 WA regular session starts Jan 13, 2020. These 13 donations totaling \$1,900 were accepted after Dec 14, 2019, inside the 30 day period when donations are not allowed. This is a violation of the law.

What impact does the alleged violation(s) have on the public?

Illegally giving a candidate running in 2020 an unfair advantage over her opponent.
