Thank you for the opportunity to respond to Case # 62659.

C3 Report #100950534 contains contributions processed online 12/13/2019, disbursed 12/16/2019, and deposited 12/17/2019. According to PDC rules, online and credit card contributions are not considered received within the freeze period provided the donor made the contribution before the freeze period began. **Exhibit A** is a screenshot from the campaigns merchant account showing amounts, contribution dates, and the transfer date. We are providing limited information at this time, to protect sensitive financial information from a public document, but more details will be provide upon request.

C3 Report #100951635 contains 2 checks that were received from the campaign mailbox on 12/23 with postmarks that predated the freeze. According to PDC rules, contributions mailed to the candidate, are not considered received within the freeze period provided the donor made the contribution before the freeze period began. **Exhibit B** shows the postmarks for those checks pre-date the prohibited period. Like the credit cards, limited information is being provided at this time, to protect sensitive financial information from a public document.
