RCW 42.17A.603 requires the PDC to **revoke your lobbying registration** if you fail to make this attestation. As of today, the PDC has not received your training attestation, which is now past due. Public Disclosure Commission (PDC) records indicate that you are registered as a lobbyist for 2020 and have not submitted an attestation that you have completed the new Legislative Code of Conduct training located at: [www.walegtrainings.com](http://www.walegtrainings.com)

In accordance with RCW 42.17A.110 and RCW 42.17A.755, an Adjudicative Proceeding (Enforcement Hearing) has been scheduled to determine if you violated RCW 42.17A.603 by failing to update your lobbyist registration to include the required attestation of Legislative Code of Conduct training completion.

In order to avoid the Enforcement Hearing, please ensure that the following items are received by the PDC by **12:00 p.m. Tuesday, January 21, 2020**:

1. An attestation on your lobbyist registration indicating that you have completed the required training, with an email notifying PDC staff at [pdcc@pdcc.wa.gov](mailto:pdcc@pdcc.wa.gov) that you have done so (see page two for instructions).
