Dear Andrew Saturn:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on January 17, 2020. The complaint alleged that People for Thurston County Jobs (Respondent) a political committee may have violated RCW 42.17A.235 and .240 for failure to timely and accurately file Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contribution and Expenditure reports (C-4 reports), disclosing contributions and expenditures undertaken by the Campaign.

PDC staff reviewed the allegations; the applicable statutes, rules, and reporting requirements; the response provided by the Respondent; the applicable PDC reports filed by the Respondent; and queried the Respondent's data in the PDC contribution and expenditure database to determine whether the record supports a finding of one or more violations.

Based on staff's review, we found the following:

- Pursuant to RCW 42.17A.235 the Respondent is required to file C-3 and C-4 reports timely.
- Pursuant to RCW 42.17A.240 the Respondent is required to accurately and completely file C-3 and C-4 reports.
- The complaint alleges that the expense for the committee's PO Box has not been reported on a C-4 report to date.
- In the response from the Respondent the expenses of PO Box and other fees were explained to have been reported in the Expenses of \$50 or Less category of the C-4 report filed on December 10, 2019 (report number 100948416).

Based on our findings staff has determined that, in this instance there is no evidence that supports the finding of a violation that warrants further investigation.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
