

## Complaint Description

On or around October 23, 2019, the City of Liberty Lake ("City") became aware of an election flyer that had been distributed in the City. The election flyer was titled as a "Neighborhood Voter's Guide" ("NVG") and contained the photographs and respective election brochures for certain candidates. As part of the NVG, the City's Logo and Flag were included. A copy of the NVG is attached to this Complaint.

The NVG endorsed the identified candidates for both City Council positions and the Office of Mayor. The City was not aware of the NVG and had no involvement in its preparation. Further, the City did not take any position on the identified candidates or those other candidates that were not included in the NVG. The City also did not provide its authorization or permission to use the City's Logo or Flag.

The NVG failed to identify the information on the party or parties involved in its creation and production, including but not limited to, the name and address information statutorily required by RCW 42.17A.320.

The City previously filed a PDC Complaint (10/24/19), but it was unaware at the time of filing of the person or persons that were responsible. Because of the lack of information for the alleged responsible party, the Complaint was closed.

The City's Police Department subsequently conducted an investigation and determined that Mr. James Alexander had prepared the NVG and distributed it in several locations within the City. Specifically, on December 19, 2019, Mr. Alexander confessed to the City's Police Chief, but only after initially denying it, that he was solely responsible for its creation and distribution.

Mr. Alexander's conduct and lack of statutorily required information in the NVG was in violation of Washington law and misrepresented certain election information to citizens that the City had created and distributed the NVG and/or endorsed certain candidates for office.

## What impact does the alleged violation(s) have on the public?

Violations of RCW 42.17A.320.

Voter election misrepresentation of candidates and/or City of Liberty Lake endorsement(s).

Improper access to and use of City of Liberty Lake Logo and Flag without authorization or approval.


It's been an honor to work on your behalf for nearly 10 years, and I respectfully ask for your support to do so for another four.






