Subject: Complaint regarding Bryan White, PDC Case 71547

Dear Daniel Barnes:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on June 7, 2020. The complaint alleged that Bryan White (Respondent), a Candidate for State Representative Position 2 for Legislative District 17 may have violated RCW 42.17A.205 & .700 for failure to timely file campaign registration (C-1) and personal financial affairs statement (F-1); and RCW 42.17A.235 for failure to timely report contributions and expenditures (C-3 & C-4).

PDC staff reviewed the allegations; the applicable statutes, rules, and reporting requirements; and the response provided by the Respondent to determine whether the record supports a finding of one or more violations.

Based on staff’s review, we found the following:

- Pursuant to RCW 42.17A.205 & .700 the Respondent is required to file their C-1 and F-1 within two weeks of becoming a candidate or no later than June 1.
- Pursuant to RCW 42.17A.235 the Respondent is required to regularly submit C-3 and C-4 reports to disclose contributions and expenditures.
- The Respondent submitted a Termination Statement with the PDC on June 9, 2020 upon being informed of the complaint.
- The Termination Statement states that the Respondent is no longer seeking office, will not campaign or accept contributions and should the Respondent accept the office, the PDC will initiate enforcement action for failure to file the reports required by Chapter 42.17A RCW.

Based on our findings staff has determined that, in this instance, failure to timely file the C-1 and F-1 does not amount to a violation that warrants further investigation.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
