Devin Beach is a candidate for County Commissioner in Pend Oreille County. I visited his campaign website <https://devindbeach.com/>, and made a donation that was greater than \$25.00 via PayPal. I was never asked for my name or full address as required by PDC Regulations.

“Anyone who donates monetary and in-kind contributions totaling more than \$25 over the course of your campaign must be identified by name and full address.”

Anyone who would request to review the Campaign Books of Account, as provided for in WAC 390-16-043, would not be able to determine the full names or full addresses of those who had contributed more than \$25.00

What impact does the alleged violation(s) have on the public?

Failure to disclose contributors, lack of transparency.





Posters or other objects (birdhouses, flags and even basketball nets) can be dangerous obstacles. Also, the nails and tacks left behind from signs can snag utility workers' boots or puncture safety clothing, putting line workers at risk to slipping or even electrocution. In addition to being hazardous, tampering with utility poles can be costly. Posting signs or attaching other objects to utility poles is illegal and can result in a misdemeanor.

PLEASE KEEP SIGNS OFF UTILITY POLES



It may seem innocent enough, but putting garage sale signs, business advertisements, birthday party balloons, lost pet posters or other items on utility poles creates serious safety hazards. Staples, nails and tacks used to hang signs, as well as the signs themselves, pose dangers to your PUD line workers who must climb poles when restoring power or while performing routine maintenance to ensure system reliability.




