Subject: Complaint regarding Michael Alvarez, PDC Case 77446

Dear Lillian "Randy" Slovic:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed June 18, 2020. The complaint alleged may have violated RCW 42.17A.555 by misusing public facilities, specifically wearing a city council pin in political advertising.

PDC staff reviewed the allegations, applicable statutes, rules, and reporting requirements, reports and data in the PDC contribution and expenditure database, and the response provided by Michael Alvarez, to determine whether the record supports a finding of one or more violations.

We found:

- Michael Alvarez registered with the PDC on May 7, 2020 as a candidate for the position
 of Benton County Commissioner, Position 1, establishing the Committee to Elect
 Michael Alvarez (Campaign) for the 2020 election, selecting the Full Reporting Option
 and listing party preference as Republican. Alvarez was elected to the City of Richland
 City Council in 2018, a position he currently holds.
- In response to the complaint, Alvarez stated he received the pin in 2015 at a Tri-Cities Chamber of Commerce meeting, noting he was "not on City Council until 2018 and did not receive the pin in question by the city."
- In addition, Alvarez stated the pins do not identify him as a city council member, stating "Once I did get on City Council, I was given a bag of them and was told if I ran out of them I could get more. I have given them to high school and college student who go to school in Richland, Local Small business owners, and dozens of Richland residents and anyone who has asked for one" and added "Anyone who wants one can get one if they ask, and that is probably how the person who gave me one got theirs."

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1). If you have questions, you may contact Alice Fiman toll-free at 1-877-601-2828, or by email at pdc@pdc.wa.gov.
