Two hours spent babysitting me are two hours they won't be campaigning.

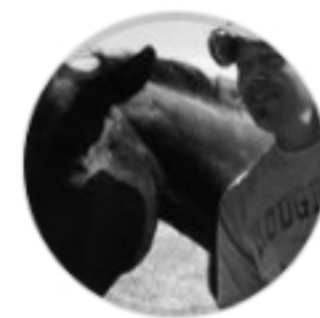
