Mr. Beach is not a first-time candidate, having run for Pend Oreille PUD Commissioner in 2018.

Early Saturday morning, July 25th, I emailed Mr. Beach requesting a Digital Inspection of Campaign Records.

At the time of this filing, I have received no response from Mr. Beach.

WAC 390-16-043:

(3) Any individual who requests to publicly inspect the books of account of a candidate or political committee, must make the request during the period beginning ten calendar days before a primary, general, or special election, by contacting the filer's email address listed on the C-1 report for a candidate...

WAC 390-16-043:

(4)The inspection must be allowed within forty-eight hours of the date and time the request was made...

RCW 42-17A.235(6)(a):

The appointment must be allowed at an authorized time and day for such inspections that is within forty-eight hours of the time and day that is requested for the inspection.


