<b>Complaint Description</b>
<p><a href="#">Returns</a> reported via the portal (<i>Thu, 23 Jul 2020 at 1:22 PM</i>)</p> <p>Attorney General candidate Mike Vaska concealed tens of thousands of dollars in paid media advertising on his most recent C-4 that covers the reporting period from 6/1-7/13. This appears to be an intentional effort to conceal strategic spending decisions from his opponents and the public at a critical time in the election.</p> <p>In his most recent C-4 filing, candidate Vaska unlawfully fails to report any spending on television ad production, television buys, political persuasion direct mail. Vaska's concealment contradicts substantial evidence that he had already paid, or incurred debt obligations, totaling tens of thousands of dollars on each of these budget items.</p> <p><b>Ad Production</b> - On July 7 2020, Mike Vaska sent out a series of emails asking for contributions to help pay for ads he was shooting that day. In his first e-mail of the day, Vaska reports that his “team was going over the ad buy and budget — and as it stands right now, our TV budget is \$11,806 short). In his last email, Vaska linked to a video posted on his campaign website offering a “behind the scenes look” at the production of his Television ads. The July 7 video clearly shows production equipment in the foreground. According to Vaska, he paid for “8 hours” of this company’s time. Vaska did not report any of this activity. I have attached copies of candidate Vaska's emails.</p> <p><b>TV Buys</b> -- Candidate Vaska failed to report over \$40,000 in campaign spending on television advertisements that started running on July 13 on cable across multiple media markets in Washington. Order Contracts from Comcast show Vaska has purchased a large amount of ad time across the state on several cable networks. See attachment.</p> <p><b>Election mailers</b> - On July 16, Washingtonians received the attached election mailer paid for by Mike Vaska. Due to candidate Vaska's unlawful concealment, it is not clear how many pieces his campaign committee mailed. **What impact does the alleged violation(s) have on the public?**

Mike Vaska appears to be intentionally concealing strategic spending decisions for costs and debt accrued before the reporting deadline. He is running for a major statewide office that enforces campaign finance violations.

Concealing tens of thousands of dollars in spending three weeks from an election is a significant material violation of campaign finance reporting rules. Moreover, there may be additional spending that candidate Vaska concealed.
