<p>Terry1955 (Thu, 30 Jul 2020 at 12:15 PM)</p> <p>The attached screenshots from the Mason County Auditor's Facebook and the Washington State League of Women Voters Facebook pages, supplied in this complaint, show the connection currently existing between the official county site and support/opposition for ballot measures through the linked LWV page. A voter who has accessed the auditors official page will quickly and almost seamlessly access the LWV advocacy on ballot issues with one click. With two clicks from the official auditor page, a voter can be presented with all LWV advocacy, including many ballot measures (in a typical general election). This is a clear violation of the RCW use of public resources "directly or indirectly" for a ballot measure campaign.</p> <p>I am providing the information below to indicate that the Mason County Auditor is not following the lead of other county auditors in the linking of LWV sites. What impact does the alleged violation(s) have on the public?																								
<p>The use of the official Facebook page has significant effects on the public in consideration of a ballot initiative. First, the use of public resources provide free advertisement to the supporters/opponents of a ballot measure. The auditor provides "free" resources to the campaign; in addition, this support goes unreported to the PDC so total support as reported by the PDC is incorrect.</p> <p>In addition, and maybe more important, the use of an official county Facebook page to support/oppose a ballot measure give the appearance that the official position of the county is what is shown via the official Facebook page. And in reality, this goes beyond appearance as the voter would correctly believe that is the position of the county. The County Commission</p>																								

does have a method of taking a position on a ballot measure, with a public vote by the Commission as a group to take a position. However, that was not done on any of the examples supplied where the county auditor's office advocated for a ballot measure on their Facebook page.

SECTIONS OF LAW VIOLATED

The county auditor has violated RCW42.17A.555 by using the official county auditor Facebook page, maintained by county employees and paid for by the public, “for the purpose of assisting a campaign for election of any person to any office or for the promotion of or opposition to any ballot proposition”.

RCW [42.17A.555](#)

Use of public office or agency facilities in campaigns—Prohibition—Exceptions.

No elective official nor any employee of his or her office nor any person appointed to or employed by any public office or agency may use or authorize the use of any of the facilities of a public office or agency, directly or indirectly, for the purpose of assisting a campaign for election of any person to any office or for the promotion of or opposition to any ballot proposition. Facilities of a public office or agency include, but are not limited to, use of stationery, postage, machines, and equipment, use of employees of the office or agency during working hours, vehicles, office space, publications of the office or agency, and clientele lists of persons served by the office or agency. However, this does not apply to the following activities:

(1) Action taken at an open public meeting by members of an elected legislative body or by an elected board, council, or commission of a special purpose district including, but not limited to, fire districts, public hospital districts, library districts, park districts, port districts, public utility districts, school districts, sewer districts, and water districts, to express a collective decision, or to actually vote upon a motion, proposal, resolution, order, or ordinance, or to support or oppose a ballot proposition so long as (a) any required notice of the meeting includes the title and number of the ballot proposition, and (b) members of the legislative body, members of the board, council, or commission of the special purpose district, or members of the public are afforded an approximately equal opportunity for the expression of an opposing view;

(2) A statement by an elected official in support of or in opposition to any ballot proposition at an open press conference or in response to a specific inquiry;

(3) Activities which are part of the normal and regular conduct of the office or agency.

(4) This section does not apply to any person who is a state officer or state employee as defined in

RCW [42.52.010](#).

WHAT IMPACTS DOES ALLEGED VIOLATION(S) HAVE ON THE PUBLIC?

The use of the official Facebook page has significant effects on the public in consideration of a ballot initiative. First, the use of public resources provide free advertisement to the supporters/opponents of a ballot measure. The auditor provides “free” resources to the campaign; in addition, this support goes unreported to the PDC so total support as reported by the PDC is incorrect.


In addition, and maybe more important, the use of an official county Facebook page to support/oppose a ballot measure give the appearance that the official position of the county is what is shown via the official Facebook page. And in reality, this goes beyond appearance as the voter would correctly believe that is the position of the county. The County Commission does have a method of taking a position on a ballot measure, with a public vote by the Commission as a group to take a position. However, that was not done on any of the examples supplied where the county auditor’s office advocated for a ballot measure on their Facebook page.






Shared post from League of Women Voters of Washington (LWV), with DIRECT ACTIVE LINK to the LWV Facebook page






