#### **Benton County Fire Protection No. 4**

The Board of Benton County Fire Protection District No. 4 is seeking the approval of a proposition to authorize that its residents be charged a property tax levy of \$1.50 per \$1,000.00 of assessed valuation collection in 2021. The proposition also authorizes annual increases of up to 6% for each of the five succeeding years. The maximum allowable levy in 2025 shall serve as the base for subsequent levy limitations as provided by Chapter 84.55 RCW. This property tax levy will be in added to existing local levy, county levy, county road levy, school levy, state school levy, enriched school levy, school bond levy, and other property tax levies.

This Proposition should be **REJECTED**.

### Kiona-Benton City School District No. 52 Proposition 1

The Kiona-Benton City School District No. Board of Directors is seeking the approval of a proposition to authorize that residents be charged an excess Enrichment Levy property tax of \$1.72 per assessed \$1,000.00 of valuation (approximately \$1,733,723.00 annually) for excess school programs. This excess enrichment property tax levy will be added to existing local levy, county levy, county road levy, school levy, state school levy, enriched school levy, school bond levy, and other property tax levies.
