<p>Shawn Anderson (Mon, 31 Aug 2020 at 11:49 PM)</p> <p>Most recent C4 disclosures for Tax Amazon 2020 list "Sure Payroll" as vendor for "payroll taxes" rather than the employees of contractors working for the campaign hiding the identify and amounts paid to individuals compensated by the campaign. This was not an issue prior to June 2020. SurePayroll simply processes employment payments and is not the proper entity to be listed on disclosure forms. Recent amended disclosures for period 6/1 to 7/13 added line items for employees listed in prior months but did not remove the line item for SurePayroll or reduce the expenditure which may result in a misrepresentation of the balance of funds in the campaign. C4 disclosure for 7/14 to end of July again disclose almost \$10,000 to SurePayroll for "payroll taxes" which is an amount not justified by direct payroll expenses disclosed. Also, C4 disclosures were not filing within 10 days from the end of the month. Tax Amazon needs to update their filings from 6/1 forward to only include processing fees for SurePayroll and disclose the ultimate payer of wages or other compensation. These do not feel like honest filing mistakes given prior proper reporting, amended updates, and the clarify of this filing requirement. Given that significant campaign payments have gone to the spouse of a Seattle city council member, there may be a purposeful effort to hide payments,</p>

Lack of transparency to individuals being compensated by Tax Amazon 2020 campaign and potential conflicts of interest might be arising from that work.
