They did not file a C3 reporting these contributions until August, 2020. They have failed to file C4 reports as required, at least for the month of April.</p> <p>I am suspicious that they have had expenditures during this period. They have taken actions to endorse candidates. There were Republican candidates on the August primary ballot. But they have reported zero expenditures during this entire calendar year. <b>What impact does the alleged violation(s) have on the public?</b>
<p>1) On 8/2/2020, the Thurston County Republican Central Committee filed a C3 report, disclosing a deposit made on 4/2/20 in the amount of \$634.20. Because that deposit was within five months of the Primary election date, that report was required to be filed by the Monday following the date of the deposit, or April 6, 2020. RCW 42.17A.235(5)</p> <p>2) On April 2, 2020, the Thurston County Republican Central Committee made a deposit into their account in the amount of \$634.20. That should have triggered a C4 filing not later than May 10, 2020. RCW 42.17A.225(2) and RCW 42.17A.235(3) There has been no C4 filed in calendar year 2020 in the PDC database accessed on 9/18/2020.</p>
