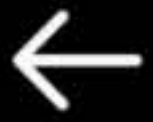

The violation is made worse by the attempt to present electioneering as unbiased informational graphics. ### CRITICISMS

**Loren Culp**



Inslee has received criticism particularly from rural Washingtonians and some business owners for his COVID restrictions and phased-in reopening of the economy.

In parts of the state outside of Seattle-King County, some Washington residents believe the mask mandate is overbearing and unnecessary.

Inslee also has come under fire from Republicans across Washington state for releasing some people from prison early to curb the impact of COVID within the prison population.

Culp has been accused in a 2017 lawsuit of botching a child sexual-abuse investigation and intimidating the victim with threats of a false-claims charge.

The lawsuit alleges that in 2013, Culp and two other officers did not properly investigate and report to state authorities allegations made by a 17-year old girl who said a male relative had been sexually molesting her since she was 5. The Benton County Sheriff eventually took over with its own investigation and promptly arrested the male relative.

A police report written by Culp in 2014 reads that Culp believed the abuser and thought the allegations made by the 17-year old victim were "made up." He still maintains the abuser could be innocent, arguing that not everyone who takes a plea deal is guilty.
