<p>Gannonsp reported via the portal (<i>Sun, 24 Jan 2021 at 10:37 PM</i>)</p> <p>Rep. Mike Volz's campaign has several violations of filing C4 expenditure reports by the deadline. 2020 was his third time running for the same seat. He is a deputy treasurer for Spokane County, incumbent representative, and treasurer for his own campaign. He should know the required deadlines for filing C4 reports.</p> <p>In fact, Rep. Volz demonstrated that he knows the rules during his first campaign in 2016. His C4 on 10/19/16 was one day late. He sent a message the next day that said he was a day late due to computer problems. This shows that Rep. Volz knew where to find the reporting deadline and paid attention to those. So much that he wanted to send in a message after submitting a report a day late.</p> <p>For his 2018 campaign, Rep. Volz filed his C1 on 06/13/2017, but did not file a C4 report until 11/10/17. He missed C4 reports on the 10th of July, August, September, and October 2017. He never filed these missing reports. In 2018, he had one C4 report that was late. He turned in the report 03/20/18 instead of 03/12/18 (the 10th was over the weekend).</p> <p>For his 2020 campaign, Rep. Volz submitted the C4 report late six different times. A report that was due on 09/10/19 was submitted on 09/24/19. Reports due on 02/10/20 and 03/10/20 were submitted on 04/10/20. Report due 09/10/20 was submitted 09/11/20. Report due 10/13/20 was submitted on 10/14/20. And the report due on 12/10/20 was submitted on 12/28/20. Two reports were a day late. Two reports were two weeks late. And two reports were more than a month late.</p> <p>Rep. Volz knows the deadlines for submitting deadlines. He has experience campaigning. He is a professional treasurer. Rep. Volz is being negligent in submitting his expenditure reports - even missing some from his 2018 campaign.
