<p>Hannie (Fri, 19 Feb 2021 at 7:06 PM)</p> <p>-Screenshot shows Mr Adams announcing his campaign on a local radio show posted on the social media platform Facebook on 5 July 2020. Although Mr Adams stated during the show itself that he was exploring running for office during the broadcast, this entry on Facebook was never modified to state as such.</p> <p>-Screenshot shows a tweet from Defendant Adams from his Twitter account showing the PDC information for Greg Wheeler a 2021 candidate running for mayor of Bremerton. If Adams is well versed with the PDC site enough to obtain this information and post it on a social media platform, then he is informed enough to know that he is in clear violation of RCW 42.17A.700 by not filing himself</p> <p>-Screenshot shows information for the Twitter account of Mr Adams. Both the twitter handle and the cover photo show clear intent that he is running for office (District 5, Bremerton) and to date, there are no PDC filings made</p>
What impact does the alleged violation(s) have on the public?
The impact of this violation is that by not filing and running as an official candidate under RCW 42.17A.700, Mr Adams is willfully deceiving the voters of the City of Bremerton. Mr Adams is concealing not only the costs of his campaign but his funding sources as well.




