| <p>To: PDC, Washington State<br/> FROM: Mary M Winkes<br/> Date: April 1, 2021<br/> RE: PDC filings of Candidate Tyler LeMasters</p> <p>There are a host of irregularities regarding Tyler LeMasters PDC filings. They are concerning violations of RCW 42.17A.235 &amp; .240 for failure to timely &amp; accurately report contributions and expenditures on C-3s and C-4s.</p> <p>Mr. LeMasters filed his C-1 on January 8, 2021. However, no other reports were filed until March 30, 2021. This is curious indeed, since Mr. LeMasters already has yard signs, business cards, website and phone that support his campaign for the Spokane City Council. (See photos below.)</p> <p>As to the specific issues, on March 30, three C-3s were filed (01/29/2021, 02/01/2021 and 02/18/2021). Those reports are a total of 88 days late as indicated directly below:</p> <p>01/29/2021—due February 10, 2021 but filed 3/30/2021—48 days late<br/> 02/01/2021—due March 10, 2021 but filed 3/30/2021—20 days late<br/> 02/18/2021—due March 10, 2021 but filed 3/30/2021—20 days late</p> <p>There are no C-4s filed as of today. There should have been C-4s filed on both February 10th and March 10th. These two reports, as of today, are a total of 72 days late.</p> <p>Since there are no C-4s filed, no expenditures have been reported. So, how are there yard signs in evidence and business cards being distributed when Mr. LeMasters door-bells promoting his campaign? These signs have been in South Hill neighborhoods for well over a month. The business card, as shown, was handed to someone at her door by Mr. LeMasters in early to mid-February. Who printed these campaign materials and when were they ordered and paid for?</p> <p>On the back side of the business card, both a phone number and a website address are listed. I checked the website and it is live. Again, there is no accounting for the campaign expense of either the phone or the website.</p> |

Also, there are problems with the C-3 reports. The 01/29/2021 C-3 states that Rancho Mirage (92270) is in CA. The second Rancho Mirage entry states that it is in WA. Similarly, the first entry on the 02/28/2021 report lists Covina (91724) in CA, however the next three donations list Covina (91724) in WA. These may be dismissed as simple mistakes, but unless one examines these reports carefully, a cursory scan would lead one to think that most of the donations to-date are local, which they are not.
