Dear Jennifer Morton,

The Public Disclosure Commission (PDC) received your request for an appeal of the Initial Order issued in the case cited above. However, because your request was not received within 21 days of the August 12, 2021 Order, it is considered a request for reconsideration under WAC 390-37-150.

The Initial Order was issued pursuant to a brief adjudicative proceeding held on July 15, 2021, in which you were found in violation of RCW 42.17A.700 and assessed a penalty of \$250 with \$150 suspended if paid within 30 days of the date of the Initial Order.

RCW 42.17A.700 requires elected or appointed officials to file a Personal Financial Affairs Statement (F-1 report) annually no later than April 15, 2021.

Based on your request, an Initial Order Reconsideration Hearing has been scheduled in your case, as provided below. The Hearing will be held before the full Commission, in accordance with RCW 42.17A.110 and .755, and WAC 390-37-144. You will have an opportunity to explain your view of the matter if you choose to attend the Hearing.
