What impact does the alleged violation(s) have on the public?
Mr. Vaccaro, candidate for the Mayor of the Town of Steilacoom, has apparently not registered and filed with the PDC either a C-1 or F-1. Thus, the public has no way to determine his campaign funding sources or any potential conflicts of interest. He has already placed campaign signs so he must be spending money and there is no apparent accountability.
